HE 13th in the Evening a small Firework was played off in a Meadow near Herrenhausen Gardens, which was performed to the Satisfaction of his Majesty, and the whole Court who were present, as also of a great Number of Spectators. The same Day at Noon, Melchior Guy Dickens, Esq; his Majesty's Secretary at the Court of the King of Prussia, whom the King had permitted to come hither for a short Time, took his Leave of his Majesty, and returned this Morning to Berlin.

Hanover, Aug. 19, N. S. Preparations are making here for the King's Journey to Celle, which continues fixed for the 26th Instant, and on the 30th his Majesty will set out from that Place for the Gohrde, where he will review a Body of Troops, and take the Diversion of Stag Hunting. The 17th Major General Millitz, who is come on the Part of the Landgrave of Hesse Darmstadt, to compliment the King on his Arrival in his German Dominions, had his Audience of his Majesty; as had also Yesterday the Bishop

Twickel, who is likewise come on the same Occasion on the Part of the Elector of Cologne: Both these Gentlemen were graciously received.

Hague, Aug. 22, N. S. Letters from Berlin advife, that on the 5th Instant the King of Prussia set out from Prague in order to return home, and arrived at Potzdam the 14th. The Elector of Cologne having lately been chosen Great Master of the Teutonick Order, the States General have written a Letter to his Electoral Highness to congratulate him on that Occasion. The States of the Province of Holland assembled on the 20th Instant, and have referred to a Committee the Assair of the Prince of Nassau-Orange's Accommodation with the King of Prussia, which had been communicated to them. The Great Pensionary has not yet been able to assist in their Assembly. The Prince of Nassau-Orange continues here.

M. was delivered to the faid Mr. Fairchild's Servant by a Boy unknown, containing the same threatning Expressions, and repeating the same Demand: Her Majesty, for the better discovering and bringing to Justice the Person or Persons concerned in so heinous a Crime, is pleased to promise His Majesty's most gracious Pardon to any one or two of them, who shall discover his or their Accomplice or Accomplices, so as he or they may be apprehended and convicted thereof.
