### Berlin, March 21, N.S.

N Thursday last the Marquels de la Chetardie, who is charged with the Affairs of France at this Court, prefented to the Ministers the Copy of new Credentials which he has received from his Court as Minister; and he is to go to Morrow to Potzdam to take an Audience of his Pruffian Majefty in that Quality, and deliver his original Credentials,

Hague, March 27, N. S. M. de Sin-zendorff, the Emperour's Minister here, has informed the Ministry, that the King of Pruffia has referred the whole Dispute between him and this Republick to the Emperour ; and that he would forthwith fend the Dutch Soldiers to Ruremond, to be disposed of as his Imperial Majesty should think sit. The faid Minister has put into the Pensionary's Hands a Copy of the King of Pruffia's Letter to the Emperour, accepting of his Imperial Majefty's Mediation, in order to be communicated to the States ; and in all Pro-bality the States will very foon come to the like Refolution. The Deputies of Zealand have prevailed with the States of Holland to joyn with them in endeavouring to perfwade the Prince of Orange to accept of an Equi-valent for the Marquifate of Ter Veer and Flufhing. Baron Bunau, who is going for England, as Minister from the Elector of Saxony, fets out from hence To-morrow to embark at Rotterdam.

And in Case any of the said Officers shall not be able to attend themselves to receive their Money, but employ Attornies for that Purpole, that the Jaid Attorneys may produce the like Certificates and Affidauits from the Perfons they are employed by.
