HE States of Holland adjourned last Saturday for a Week, after having passed a Resolution to put off the Resorm of the Troops to the 29th of July next. Count Sinzendorff received to Day an Answer to the Memorial he prefented, touching the Protestant Counsellor no-minated by the States to be one of the Court of Justice at Venlo: Their High Mightinesses insist on their Right to that Nomination. On Saturday last their High Mightinesses sent a Deputation to the Marquess de Fenelon, the French Ambassadour, to compliment him on the Birth of a Princess of France; on which Occasion it is said he will make a great Entertainment some Day this Week. Count de Canales is arrived, being to reside here as Minister of the King of Sardinia, in the Room of Count Chiusan, who went away fome time ago. Mr. Finch, Minister from the King of Great Britain, has been in Con-ference with some of the Lords of the Regency.
