Hague May 18, N. S. The States of Holland separated last Saturday, and are to meet again To-morrow Seven-night, to refume feveral Domestick Affairs which they have left The Accounts which we have undecided. here from the Rhine advise, that all the different Bodies of the French Troops, as well that which was upon the Moselle, as the others, had joined the Duke of Berwick, who marched with a Design to bring Prince Eu gene to a Battle before the Reinforcements which he expects should join him. Letters from Dantzick of the 8th fay, that the Muscovites had already thrown into the City 500 Bombs; that it was faid they had no more, and that the City defended itself still bravely, in Expectation of the French Succours. Those from Milan of the 7th, confirm Their the Imperial Troops passing the Po. Royal and Serene Highnesses the Prince and Princess of Orange made their Entry into Leewarden the 11th Instant with great Magnificence. The Burghers, who were under Arms, saluted their Highnesses at their Arrival with a triple Discharge; in the Evening there were Illuminations, a fine Firework played off, and all other publick Demonstrations of Joy.
