The Assembly of the States of Holland remains fixed to Wednesday next. The last Letters we have received here from the Armies in Italy are of the 12th Instant, and advise, that both Armies continued in their Posts, but that the Imperialists had received Part of the Succours ordered to them, and were expecting the rest very foon.
