They returned accordingly, and unanimously chose the Right Honourable Arthur Onflow, Esq; to be their Speaker.

And their Loraships ao herevy give Notice to all Massers of Ships or Vessels belonging to His Majest,'s Subjects who may receive Passes, either from this Office, or from any of the Governors of His Majesty's Foreign Islands or Plantations, that by an AEP passed in the Fourth Year of his present Majesty, it is made Felony, without Benefit of the Clergy, if any Erasement or Asteristion whatsoever shall be found and in any such Passes.
