Warsaw, January 26, N. S.

THE General Council was opened on the 24th by a Speech from the Marshal of the Confederation, Ponninski, upon the present Situation of Affairs, which was answered by the Bishop of Cracovy, as Vice-Chancellor, in the Name of King Augustus, and the Council afterwards adjourned till to Morrow, when several Points are to be given them in Writing to be consider'd on, and probably they will be farther adjourn'd from time to time, till they hear of the Success of the Commissaries sent to the Palatin of Kiovy. We have Accounts by two Couriers, that are very lately come from the Army of the said Palatin, that he continues in his Resolution of submitting to King Augustus, and waits only the Arrival of the Commissaries to settle the Armistice; that as soon as it was known to those Troops that are paid by the Republick, and which were with the Palatin of Lublin, that their Regimentary intended to demand an Armistice in order to make his Peace with the Court, most of them immediately joined him, and he had before gain'd the few regular Troops, called Foreign Troops. General Lacy received an Exprels from his Court the 22d Instant, by which he has Orders to put under March for Cracovy 16 Regiments of Foot, and 10 Regiments of Horse, which are to be joined by 6000 Recruits that are coming from Muscovy, 1000 detach'd from Lieutenant General Ismailow, and as many from the Prince of Hesse Hombourg, making in all about 30000. He is to command them himself, and is this Day returning to his Quarters, where he will give his Directions in pursuance of his Orders. As Cracovy is near the Frontiers of Hungary and Silesia, it is said these Troops are to wait thereabouts, to be at Hand to be employed as the Emperor shall have Occasion.

Hague, Feb. 11, N. S. His Excellency Mr. Walpole left this Place this Morning to go on Board his Majesty's Yacht at Helvoetsluys, in order to sail with the first fair Wind for England. The States of Holland now sitting, will continue their Assembly next Week. The great Storm we had lately, has occasioned already several Bankruptcies

at Amsterdam, where 'tis computed at present that the Loss alone in the Texel amounts to above Four Millions of Florins. Two East India Ships that happen'd to sail at that Time from Middlebourg for the Indies, perished with their whole Crews, at some Distance off the Coast of Zealand; whereupon the East India Stock is already fallen Five per Cent.

And as a further Encouragement, his Majesty is also pleased to promise a Reward of Fifty Pounds for every one of the Criminals who shall be discovered and apprehended as aforesaid, to be paid upon the Conviction of the Offender or Offenders.
