leldt - Marshal Munich has received Advice, that on the Approach of the Russians, the Troops of King Stanislans's Party in Lithuania retired with the greatest Precipitation, passed thirteen Miles over the King of Prussia's Dominions, and are gone into the Bishoprick of Warmia; that Orders were given for following them that Orders were given for following them directly the same Way, and Dispositions were making for surrounding them, which it was thought would not be a very difficult Matter, by Reason of the Situation of that Country. It is faid here, that the Regimentary Poccey is at Konigsberg, as also the Palatin of Volhinia, and that the Command of the Troops, during their Absence, was lest to M. Mas-salski, Starost of Grodno. It is also reported, that these Troops in their March seemed inclined to submit themselves to King Augustus, foreseeing no likelihood of Assistance. Farther News of them is daily expected, We have heard of the Palatin of Lublin's being at last got safe out of this Country, with a very few Persons with him; and it is not doubted but he is at Konigsberg before this Time. General Lacy arrived here the 26th Instant, and Conferences are held with him about the Number of Rullian Troops that are to be at the Emperour's Disposal: General Lacy himself has received Orders from his Court to command them; and to march directly for the Rhine, and he is going away within two or three Days at farthest for that Purpose. He reckons 11000 Men to be all he can take with him at present, and which are ready near the Frontiers of Silesia, but that he shall be soon followed by others.

The Prince of Weissenfelds is expected here this Asternoon; The Primate has writ to the Bishop of Cracow, that he had seen that Prince at Thom, to whom he refers to explain his Sentiments, having open'd himself very fully to him. The Grand Marshal, Palatin of Kiow, and Castellan of Cracow, are said to be so near this Place, that they will certainly be here in a few Days; their Arrival is impatiently waited for, that it may be determined in what manner to proceed, in order to have a general Pacification in this Country; Some are for having a Dyet of Pacification, others a Dyet Sub Vinculo Confoederationis, and others a great Council; the First requires an Unanimity of Voices to regulate any Point; in the Second, a Majority is sufficient, but will not give the Force of a Law without an Unanimity; and in the Third, the Majority decides every Thing, though the Sanction of a Dyet is required afterwards.

Berlin, May 7, N. S. Our Advices out of Poland fince the 30th past are to this Effect: That M. Poccey, the Regimentary of Lithuania, with the Troops under his Command, being got into the Bishoprick of Warmia, the Russians had followed them thither, crossing over his Prussian Majesty's Territories. Some say the Russians desired Leave, but others, that they have taken it. We expect every Moment to hear that M. Poccey has met with the same sate as Count Tarlo; after which, all the Parties under Arms for King Stanislaus, worth speaking of, will have submitted, or will have been dispersed.
