HE States of Holland are still affembled. The Conferences which have been held during this Assembly about the Promotion of General Officers are continued, the Deputies of the respective Provinces having not yet come to any Agreement thereupon. Three Days ago the Marquess de Fenelon received a Courier from his Court, and it is believed that he and the Imperial Minister Count, d'Uhleseld will communicate in a sew Days to the States in Form the Preliminaries of the Treaty of Peace between the Emperor and the most Christian King.
