Madrid, March 12, N. S. Esterday Monsignor Caraccioli, who lately arrived from Rome with the Cap for the Infant Cardinal, performed the Ceremony at the Pardo usual upon such Occasions, in the Presence of their Catholick Majesties, the rest of the Royal Family, and a great Concourse of the chief Nobility of this Court. The Duke of Bournonville has been appointed Commander in Chief of this Body of Troops in Quality of Captain General, and the two Lieutenant Generals under him are to be the Marqueis de Bedmar and the Marquess de Monreal. This being Her Britannick Majesty's Birth-day, Mr. Keene, the British Plenipotentiary, gave upon this Occasion a splendid Entertainment to his Excellency Sig Tarrho, all the foreign Ministers, the great Otheras of State, several Grandees, and other Pe ous of Distinction.
