THE King of Poland is expected here the 19th Instant from Hurbertsberg, and it is reckoned his Majesty will pass the Winter here. The Letter which it has been said was intended to be written by his Polish Majesty to King Stanislaus, in order to give him the Title of King, and thereby satisfy the French, is not yet done, but it is said the Execution of that Point will not be deferred much longer.

Hambourg, Nov. 14, N. S. The separate Article of the Convention between his Danish Majesty and this Town, which was signed and sealed about four Months since, and was soon after ratified by the King of Denmark, has now been approved in Form by the Magistrates of this City.

Hague, Nov. 23, N. S. Letters which came in this Morning from Paris, advise, that a Courier expected from Vienna was arrived, and had brought (as is given out here) the Emperor's Consent to the Conditions demanded by Spain, for putting an End to the Affairs in Agitation; and that for certain the Evacuation of Tuscany will be made next Month, and that of Philipsbourg and Kehl the 15th of that Month. The States General have promoted Major General Wichers to the Rank of Lieutenant General, in the Room of M. Caris, deceased.
