OUNT Perouse, the new Bavarian

An Imperial Courier returned hither on Sunday last from Petersbourg, with Advice of Felt Marshal Munich's having lest Petersbourg on the 3d Instant, in order to go to the Muscovite Army and hasten the Preparations against the Turks; and with fresh instances from the Czarina to this Court, to concert proper Measures, and act in Conjunction with her on this Occasion.

Charles Wassenaer to that of Grand Baily of the Hague, and Count Hompesch is made Grand Forester of Holland, both which Places were held by the faid late M. Boetfelzer; and M. Vander Duyn has succeeded M. Wassenser in the Command he had of the Foot Guards.
