HE Czarina was last Night pleased to name Artemy Petrovitz Volinsky, Baron Shassirof, and M. Neptues, to be her Czarish Majesty's Ministers Plenipotentiaries, for treating of a Peace with the Ministers Plenipotentiaries appointed for that Purpose by the Ottoman Porte.

St. James's, March 31.

And as a further Encouragement, His Majesty is also pleased to promise a Reward of Fifty Pounds to any one of them, or to any other Person or Persons, who shall make such Discovery as aforesaid; to be paid upon the Conviction of the Offender or Offenders.
