IS Majesty came this Day to the House of Peers, and being in His Royal Robes, seated on the Throne with the usual Solemnity, SirCharles Dalton, Gentleman-Usher of the Black Rod, was sent with a Message from His Majesty to the House of Commons, commanding their Attendance in the House of Peers; the Commons being come thither accordingly, His Majesty was pleased to give the Royal Asfent to,

An Act for granting an Aid to his Majesty by a Land Tax, to be raised in Great Britain for the Service of the Year One thousand seven bundred and thirty seven.

An Act to make perpetual an Act made in the seventh Year of the Reign of his present

Majesty, Intituled, An Act to prevent the in-famous Practice of Stockjobbing. An Act for the better repairing and paving the Highways, Streets, and Watercourses within the City of New Sarum, and for en-lightning the Streets, Lanes and Passages, and better regulating the Nightly Watch within the faid City.

An Ast for enlarging the Term granted by an Ast passed in the twelfth Year of the Reign of his late Majesty King George the First, (intituled, An Act for repairing several Roads therein mentioned leading into the City of Worcester, and for repairing several other Roads lying contiguous to the same) and for reducing the Toll or Duties granted on Sheep and Lambs, by the said Act.

An Act for making more effectual two Acts of Parliament, one of the fixth Year of the Reign of her late Majesty Queen Anne, and the other of the eleventh Year of the Reign of his late Majesty King George, for repairing the Highways from Old Stratford in the

County of Northampton, to Dunchurch in the County of Warwick.

An Act to empower the Justices of the Peace for the County of Bucks, to raise Money to discharge the Debts incurred on account of ruilding a Goal and Court-Rooms, and for fiishing the same for the Use of the County.

An Act for continuing an Act passed in the third Tear of the Reign of his late Majesty King George the First, for laying a Duty of two Pennies Scots or one fixth part of a Penny Sterling, on every Pint of Ale or Beer that shall be vended or sold within the Town of Dunfries and Privileges thereof, for paying the Debts of the said Town, and for building a Church and making a Uniham a Church and making a Harbour there, and for laying a Duty on the Tonnage of Ship-ping, and a Duty on Goods imported and exported into and out of the Port of the said Town for the better repairing of the said Harbour.
