Petersbourg, April 9.

THAT Part of the Russian Army which is to be commanded by Felt-Marshal Count Munich, and which is to consist, some say of 70, and others affirm 90,000 regular Troops, besides a vast Number of Tartars, Cossacks, and Calmucks, is in full March to assemble at Zari-zinka; and it is generally believed here, that the Felt Marshal designs very soon to besiege Oczakow on the Mouth of the River Nieper, to try to engage the Grand Vizier to come to a Battle in order to relieve that Place. All the Ammunition and Provisions for the Army are to be carried down the Nieper by the Boats that have been built this Winter at Bransky. The other Part of the Russian Army, that is to be commanded by Felt-Marshal Lacy, and which is said to consist of 40,000 regular Troops, besides Tartars and Cossacks, is assembling at Issum on the River Donetz, and is to attack the Crimea, at the same time that a great Number of Boats, which have been built this Winter at Taurus on the River Don, are to carry other Troops over the Sea of Asoph, and attack also that Country. Major-General Biron, one of her Czarish Majesty's General Adjutants, and Brother to the Great Chamberlain, set out from hence the 6th Instant in order to join the Army.

Copenhagen, May 4, N. S. The Margravine, who seems perfectly recovered, dined Yesterday in Publick with the Royal Family as usual. In the Afternoon the Prince Royal saw his own Regiment perform their Exercise, and pass in Review before him. The same Day Count Hemburg, and M. Bulow a Captain in the Horse Guards, were both made Chambellans; Baron Wantzen, a Gentleman of the Electorate of Hanover, was likewise admitted Gentleman of the Bed Chamber.

Hague, May 10, N. S. The States Answer to the King of Naples's Letter notifying his Accession to that Crown, was delivered Yesterday to the Spanish Ambassadour to be forwarded this Day. The States of Holland are assembled, and like to sit till the End of next Week, having many domestick Affairs under their Consideration; and particularly Complaints from the City of Rotterdam, relating to the Customs collected there.
