Eneral Seckendorff is continuing his March towards Zwornick: But he must take a small Place which lies in his Way, called Uschtza, where there are some Fortifications and a very strong Garrison, besides a separate Body of Turks intrenched behind it. It is supposed that General Seckendorff may have arrived at Uschtza about the 16th Instant. It is assured that Prince Ragotzi, and Bonneval are marching with a Body of Turks towards General Wallis in Wallachia. The Duke of Lorrain, who had been out of Order, but was so well recovered as to dine in Publick last Sunday with the whole Imperial Family, fell ill again on the Monday following of a severith Indisposition, which still continues on him; however the Physicians did not apprehend any Danger this Asternoon. Prince Charles his Brother arrived here this Morning tolerably recovered, but so weak, that heither he, nor the Duke and the Dutchess will accompany the Emperor to Halpturn; for which Place his Imperial Majesty sets out To-morrow Morning.

Vienna, Sept. 21, N. S. We are now in daily Expectation of a Courier with an Account of what may have happened at Ulchtza, about five Days March from Zwornick. This Court has received Advices of the 1st Instant from Felt Marshal Munich's Army, that he intended to march to Bielgorod upon the Black Sea, and to take that Place; in which Undertaking it is thought he may be able to succeed, with the Help of the Russian Fleet. His Royal Highness the Duke of Lorrain is much in the State of Health that he was three Days ago.

Copenhagen, Sept. 28, N. S. The Funeral of the Margravine was performed on the 19th Instant, with Royal Solemnity. Their Danish Majesties removed to Friedericksbourg some Days before, and are since gone to Wal-

loe. The Privacy which their Majesties continue so long to observe, is probably owing to the Tenderness of the Queen, who is as yet too sensible of her Loss to undergo the usual Ceremony of receiving Compliments of Condoleance upon it. The Prince of Wirtemberg Oels set out Yesterday for Germany, proposing to return hither in April. M. Benzon, who has been appointed President of the Chamber of Finances, and is also to be one of the New College of Commerce, is now arrived here. Last Tuesday died suddenly, at the Age of 51, Major General Reventlau, who commanded the Regiment of the Prince Royal.

Hague, Oct. 8, N. S. His Excellency Mr. Walpole is gone to Breda, on a Visit to the Prince and Princess of Orange, and is expected back the 11th Instant. The Accounts we have of the Army in Hungary, represent the Imperialists to be in a weak Condition, Numbers of Men being carried off daily by Sickness occasioned by bad Weather and Want of Provisions; particularly the Body of Troops commanded by the Prince of Saxe Hildburgshausen; encamped near Gradisca, was considerably reduced; and even the People of that Country, though used to Change of Weather, suffered much by the Mortality that has spread among them. The Mortality had likewise begun to seize the Cattle.
