Whitehall, November 22.

N Sunday the 20th Instant, between the Hours of Eleven and Twelve at Night, the Queen departed this Life, after an Illness of twelve Days, to the inexpressible Grief of His Majesty, and the Royal Family. The many great and exemplary Virtues, which so eminently distinguished Her Majesty in every Character of Life, and had long been the Object of universal Esteem and Admiration, render the Death of this most excellent Princess an unspeakable Loss to the whole Nation.

Vienna, Nov. 13, N. S. According to our Advices from Hungary, the Turks have retired from Servia, after having left a Garrison of 4000 Men in the Town of Nissa, and 8000 at Widdin. "Tis also advised, that the Grand Vizier was to set out the Beginning of this Month from Isacka for Adrianople, whither it was said the Grand Signior will repair éarly next Spring. That the Basha of Bosnia had repassed the River Drin, and retired with his Troops: As to Usitza, it is supposed it will be retaken by the Turks, if not abandoned by the Imperialists. Yesterday in the Evening an Adjutant General set out from hence, with the definitive Orders of this Court to Count Philippi, with Regard to the Winter Quarters. The Imperial Garrison of Nissa is safely arrived at or near Belgrade, where General Doxat was put in Prison as soon as he arrived, and a Council of War is said to have been appointed for his Trial; his best Friends are at a Loss how to account for his Conduct in giving up Nissa to a Body of 12 or 14000 Turks, who had no Cannon with them. There has been a great Talk in Town for several Days past, of Commissaries being to be appointed to examine Count Seckendors Sconduct, but as yet they are not named. M. Lazenski has been observed to have been more active of late than usual, in order to magnify the Dispositions the Czarina is making for the next

Campaign, and to encourage this Court to try the Event of it before they hearken to any Propositions of Peace.

Vienna, Nov. 16, N. S. Since the last Post this Court has received a Courier from Transilvania, with Advice, that the Turks having only, seigned to retire from Walachia, had fallen on a sudden with a strong Body upon Krajova, which is the Principal Town of the German Walachia, and had surprised it in such a Manner that about 600 Foot, who were in Garrison there, were all cut to pieces, except the Commandant and some other Officers, who are said to have found Means to escape. The Affair of Count Seckendorff seems now to be quite dormant; no Commissiones are yet appointed. Prince Lichtenstein sets out to Night for Paris by the Way of Brussels.

Hague, Nov. 26, N. S. The States of Holland separated last Saturday, in order to meet again the 11th of next Month. The Resolution of the States General upon the last Answer of the Courts of Vienna and France, with respect to Bergue and Juliers, was delivered Yesterday to the Imperial and French Ministers.
