Tenants.

An Act to indemnify Persons who have omitted to qualify themselves for Offices, or to read the Prayers, and make the Declaration ons and Subscriptions required within the respective Times limited by Law, and for allowing further Time for those Purposes.

An Act for allowing further Time for Incolment of Deeds and Wills made by Papists,

and for Relief of Protestant Purchasers, De-

vifees and Lessees.

An Act for the Relief of such Prisoners for Debt as have by unavoidable Accidents lest the Benefit of an Act passed in the last Session of Parliament, intitled, An Act for Relief of Insolvent Debtors.
