Petersbourg, June 24.

ETTERS from Felt Marshal Munich dated the 7th Instant, relate, that the Russian Army was but then come to the River Ingul, where they found about 40 Janissaries, some of which they took Prisoners, by whom the Felt Marshal was informed, that two Seraskiers and 30000 Turks were at Bender, with 20000 Tartars, and that a Capachi Bashaw was arrived from Constantinople at Bender, with Orders that the Troops in that Place should march out on the Approach of the Russians, and give them Battle, to prevent their passing the River Dniester. The 17th Instant a dismal Fire happened at Wibourg in Finland, which in a very few Hours confumed all the Town to Ashes, except two Churches, but the Powder Magazine was not blown up, so the Fortifica-tions remain entire. Yesterday being the young Princess of Courland's Birth-day, who then entred into the 12th Year of her Age, all the Foreign Ministers and Russian Nobility went in the Morning to make their Compliments to the Princels, and to the Duke and Dutchess.

Copenhagen, July 15, N.S. Their Danish Majesties having made a Progress to Wallde and Wardingburg, are come back to the Palace of Rosenburg in this City, and will remove again in a Day or two to Fridericksbourg. During the Progress his Danish Majesty reviewed the Regiments of the Prince of Wirtemburg Oels, and Stevens Cavalry; and has been pleased to conser upon the said Prince the Command of the Horse Guard, vacant by the late Promotion of General Schulemburg. To Day Count Daneskiold entertains the Court on board a Vessel in this Road.
