Hambourg, Aug. 5, N. S. The Night be-fore last an Express from Berlin, dispatched by Baron Brackel, the Russian Minister there, passed through this City for Copenhagen, with the important News, that General Lacy had on the 7th past attacked the Tartar Kan in his Lines of Perecop, and obtained a compleat Victory, taking a great Number of Prisoners, with 80 Brass Cannon and Mortars, several Iron Guns, and a vast Quantity of

other Booty, Ammunition, and Provisions. Hague, Aug. 8, N. S. Count Gallowkin, the Czarina's Minister here, has communicated to the States an Account he had received, that the Russian Army under the Command of General Lacy, had once more made themselves Masters of the Lines of Perecop on the 7th of July: About 40,000 Turks and Tartars were posted in those Lines, who made very little Resistance, but, on the Approach of the Russians, retired back into the Crimea with great Precipitation. On the 8th the Russians advanced to the Fortress of Perecop, in which was a Turkish Garrison commanded by a Bashaw of three Horse-Tails. neral Lacy with all Diligence caused Batteries to be raised of Cannon and Mortars, which made so brisk a Fire, that on the 10th the Turkish Garrison surrendred, yielding themfelves Prisoners of War, to the Number of between 2 and 3000 Men. In the Place were found above 80 Brass Canon and Mortars. Letters from Vienna of the 26th of last Month advise, that the Turks had renewed the Siege of Orsova; that the Imperial Army had marched from Meadia to Caransebes; and that the Grand Duke of Tuscany, having for some Days had a Fever upon him, was gone to Buda. The King of Prussia having made a Visit to the Prince and Princess of Orange at Loo, is gone back to his Country I

of Cleves, without making a Turn to Holland as was expected. M. Hamilton, who was lately in England, is returned hither, with the Character of Envoy Extraordinary from the Duke of Holstein to the States General.
