From the Imperial Camp at Lugos, July 27.

Efterday about Six in the Evening, the Garrison of Meadia, and a Regiment of Hussar from Teregova, arrived at the Camp. This Morning at Four, a Courier arrived from Count Munich, with an Account that the Russian Army, consisting of 90000 Men, had passed the Bog; and that on the 11th Instant the Turkish Army, consisting of about 100,000 Men, Turks and Tartars, endeavoured to force their Camp 14 Days March from Bender, but were repulsed and lost a good Number of Men; the Loss of the Russians was but 100. The Baggage marched this Morning at Six, and the Army is to march at Eight towards Belgrade.

Dresden, Aug. 13, N. S. A Courier is arrived here from Naples with Advice, that their Sicilian Majesties continue in good Health, and that the Electoral Prince Royal received Benefit from the hot Baths. According to the last Advices from Poland, we may soon have News, either that Bender is besieged, or Count Munich repulsed; for when those Advices were dispatched, which was about a Fortnight since, he was but five Days March from the Dniester, and the Turkish Army had been reinforced by 15000 Janissaries. The Poles begin to be very apprehensive from the Violence of the Plague in Temeswaer, and all over those Parts. Our last News from the Army in Hungary came by the Way of Vienna; in general they confirm the Loss of Meadia, and the bad State of the Imperial Army, occasioned by Want of Provisions, by the Dysentery among the Soldiers, and Variance among the Generals.

They have both been frequently seen at Horse Races, Garding-Tables, Hazard, and Cocksighting Matches.
