Hague, Aug. 22, N.S. New Conferences have this Week been held by the Imperial, British, and French Ministers, with the Deputies of the States, concerning the Affair of Juliers and Berg; at which the Imperial and French Ministers delivered to Mr. Trevor and the Deputies fresh Memorials. The States of Holland are to separate To-morrow. The States M. Ginkel is arrived here from the Court of Berlin: The King of Prussia having conferred upon him his Order of Knighthood, he has asked Leave of the States to wear the Enfigns of that Order, which their High Mightinesses have granted. Prince George of Hesle Cassel is expected here from Loo, where he has been to visit the Prince and Princess of Orange. By Letters from Stockholm of the 1st Instant, we learn, that the King of Sweden had been extremely ill, but was then judged to be out of Danger, and in a fair Way of Recovery. There are Letters from Petersbourg of the 2d Instant, which advice, that it was rumour'd that there had been a second Action between Felt Marshal Munich and the Turks near the River Lavrin, upon the Frontier of Poland.
