Petersbourg, August 1.

Courier arrived here the 29th of July, in the Evening, from Felt Marshal Lacy, who brought Letters dated the 13th of the same Month, by which the Czarina is informed, that a confiderable Body of Turks and Tartars, eight Versts from the Perecop, had attacked his Advance Guard, confishing of a Regiment of Dragoons, and the Ukraine Cossacks, which they probably would have destroyed, if Lieutenant General Spiegel, with four more Regiments of Dragoons, and Krasna Chokin with his Don Cossacks, had not come to their Affistance, who after a very sharp Action, entirely defeated the Turks, and took a Tartar Murza, or Prince, Prisoner, with several Colours that Felt Marshal Lacy sent to her Majesty by one of his Adjutants two Days before this Account; but as he is not yet arrived, all the Particulars are not yet known. It is assured however, that there were 15000 Turks and as many Tartars in the Action, above 3000 of which were killed on the Spot. A Courier is also arrived from Felt Marshal Munich, with Letters dated the 14th of last Month, on the Banks of the River Condina, about 15 Versts from the Turkish Camp, for they have passed the Dniester with all their Army Horse and Foot, in order to fight the Russians. Count Munich mentions, that he defigned to leave his heavy Baggage, and continue his March the 15th, and rest his Army the 16th, in order the 17th to attack the Turkish Army in case they don't retire; so that we daily expect to hear of a decisive Battle.

Vienna, Aug. 20, N. S. We have certain Advice of the Entrance of the Succours into Orsova, which were lately sent from Belgrade. The Grand Vizier is still at Cladova, and the advanced Turks are said to be even at Lugos. It is now politively affirmed, that his Royal Highness the Great Duke of Tuscany will set out for the Army on the
