Petersbourg, August 26, O. S.

N the 22d Instant at Night Captain Innis, a Scotch Gentleman in her Czarish Majesty's Service, arrived at Petershoff, being sent by Felt Marshal Munich with the Particulars of the Action which happen'd after the Russians had retired from that Part of the Dniester where the Turks had raifed fuch Works to oppose their Passage that the attempting it was judged impracticable. The Felt Marshal designing to endeavour to pass that River higher up in the Neighbourhood of Saroka, and taking his Way by the River Bilocze, was attacked near it by 25000 Janissaries, and many Thouland Spahis, Arnouts and Aliatick Horse, and all the Tartars of Biclogorod and Nogay; but the Enemy were defeated after losing several Thousand of their best Men. The Russians on this Occasion had not above This great 500 Men killed or wounded. Success was made known to the People on the 23d in the Morning, by the firing the Guns of the Citadel and of the Admiralty.

Francis Kelham, a listle Man with a red Complexion, who lately kept the Rose and Crown Ale-house in Bartholomew Close, till be absconded. They have both been frequently seen at Horse Races, Gaming-Tables, Hazard, Cocksighting Matches.

David Roberts, by Trade a Carpenter, about & Foot 8 or 3 Inches high, of a fairish fresh Complexion, about 35 Years of Age, who kept the Coach and Horses Inn in the City of Coventry about two Years ago, since ledged in Cold Bath Fields; London, afterwards at one Williams, a Chandler on Saffron Hill, afterwards moved and kept a House in the Market-place, Hoxton, from thence moved to the Broad Santtuary, Westminster, from thence to the Mulberry Garden in St. George's Fields, Southwark, from shence to Wood's Close near Clerkenwell;

his last Habitation was near the Three Hats, Islingson, Joseph Benson, about & Foot 6 Inches high, between 60 and 70 Tears old, stoops a little, wears a Wig, and his Hair pretty long under it, and is a thin spare Man, born near Naresborough in Yorkshire, by Trade a Gunborn near Naresvorough to terripire, or trage a Gun-fmith, noted for making Crofs Bows, formerly lived in Dublin; bis last Place of Habitation was at Cats-Hole in St. Catherine's, near the Tower.
