Crews or Merchandizes, and they shall pay faid threatning Letter, who shall discover his Accomplication Tolls to our Guard Ship. For this plice or Accomplices, so as they or any of them; be appropriate we have given the necessary Orders that the Officers of our Guard Ship do give Notice to all Ships coming from Dantzick, Konigsberg, and the Neighbouring Ports and Courses to any Person or Person making the Konigsberg, and the Neighbouring Ports and Places abovementioned, that they may be instantly dispatched on board the Guard Offender or Offenders. Ship, and may be supplied with what they may have Occasion for in their Voyage; but no Person on board such Ship shall be permitted to go ashore.

8. All Pilots, Fishermen, and others who have their Dwellings near the Sea, and more especially those of Drago, are expresly forbidden to go on board any one Vessel soming from the East Sea, much less to take into their Boats any of their Men or Merchandizes; but when such Ship has need of Pilots, then the Pilot with his own Boat shall go before to fhew her the Way, and keep at fome Distance when he speaks with the Men of the Ship. He shall take the Money that is due to him in a Dish or Cup with Salt

Water therein.

We expresly forbid all whom it may concern, to act in any Point contrary to what is above, under Pain of Corporal Punishment. We charge our Vicar in our Kingdom of Norway, Counts, Grand Bailiffs, Bailiffs, Provincial Judges, Presidents, Magistrates, Mayors, and all others, to whom this our Ordinance shall be sent, under the Seal of our Chancery, to cause it forthwith to be read and published in the publick Places, to the End that all may be informed of it; and to see Obedience paid to it. Given at our Castle at Fridericksberg the 7th of November 1738. under our Royal Hand and Seal.
