A PROCLAMATION.

GÈORGE R. HEREAS our **Parliament** stands prorogued to Thursday the Seventh Day of December next; We, with the Advice of our Privy Council, do hereby publish and declare, That the said Parliament shall be further prorogued on the faid Seventh Day of December, to Thursday the Eighteenth Day of January next ensuing: And we have given Order to our Chancellor of Great Britain to prepare a Commission for proroguing the same accordingly. And we do hereby farther declare our Royal Will and Pleasure, That the said Parliament shall, on the said Eighteenth Day of January next, be held, and sit for the Dispatch of divers weighty and important Affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesles, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required to give their Attendance accordingly at West-minster, on the said Eighteenth Day of January next.

Given at Our Court at St. James's the Thirtieth Day of November, 1738, in the Twelfth Tear of Our Reign. GOD Save the KING.
