Warfaw, March 11, N.S.

T is faid the Emperour has defired an Augmentation of Saxon Auxiliaries. Major General Renard, who commands the 5000 Saxons now in Hungary, is made Lieutenant General; and Colonel Roc-kow, who is there with his Regiment, is made Major General; and it is probable there will be a general Promotion of Officers when the Court returns to Saxony. A Courier arrived Yesterday Morning in 13 Days from Naples, with a Letter writ by the Queen of the Two Sicilies, to assure his Polish Majesty of her perfect Recovery.

Vienna, March 14, N.S. The Emperor having been of late indisposed of the Gout,

grows better and better daily.

Copenhagen, March 14, N. S. This Day a Treaty of Defensive Alliance between his Britannick Majesty and the King of Denmark,

was figned here.

Berlin, March 17, N. S. We hear from Potsdam, that the King of Prussia's State of Health is so much mended, that he frequently takes the Air on Horseback or in a Chaise.

Antwerp, March 21, N. S. Last Week Count Maldeghem and M. Patin came hither, and have had several Meetings with the other Imperial Commissaries, but did not desire a Conference till this Day, which was accordingly held at the Stadt-House. The Imperial and Dutch Commissaries produced on each Part, and compared, Copies taken from the original Map made in the Year 1664, for the Separation of the antient Limits in purfuance of the Treaty of Munster in 1648, and found and agreed, that the Description of them as therein mark'd was exactly the same. They will have another Meeting in a few Days.

Bank, 14 December, 1738.

Upon a Representation from His Majesty's Postmaster-General, That it is apprehended that the Expectation of finding Bank Bills in the Letters, gives Encouragement to the frequent Robbery of the Mails; The Bank of England, to contribute what in them lies to put a Stop thereto, and to render their Bills of no Significancy or Value to those who are guilty of such flagitious Practices, do declare, That for the Benefit and Security of those who have Occasion to transact Money Affairs in the Country, they will from and after the First Day of January next (instead of Three Days Sight Bills) give to such as desire the same, their Bills payable at Seven Days after Sight to Order, whereby in Case of a Robbery, the Proprietors will have Time to give Notice thereof; and if the Indorsements are duly filled up, as they expect they should, they can be of no Uje or Service but to the right Owners.

And whereas they may fall into those Hands who may be ignorant of the Form of indyssing them, a Blank Indorsement will be printed on the Back for the Parties to fill up, and so be repeated as often as Oc-
