Vienna, May 27, N. S.

THE Great Duke and Dutchess of Tuscany are expected here on Saturday next. The Dutchess Dowager of Lorraine came as far as to Inspruch, to see the Grand Duke and Prince Charles her Sons, and the Grand Dutchess her Daughter-in-Law, and had the Pleasure of passing three or four Days there with them.

Vienna, May 30, N. S. Their Royal Highnesses the Duke and Dutchess of Tuscany, and Prince Charles of Lorraine, being arrived by Water in the Neighbourhood of this City, passed by this Morning about Eight of the Clock in their Way to Laxemburg, being saluted from our Ramparts with the firing of 30 Cannon. The Elector of Bavaria having offered, besides the Recruits necessary to compleat his Troops already in Hungary, 850 Horse, and 700 Foot, they have been accepted; so that the Bavarian Troops in the Imperial Service will amount to 9000 Men this Campaign.

Hambourg, June 2, N. S. The Duke of Holstein's Indisposition seem'd at first to be attended with such bad Symptoms, that his Highness was judged to be in great Danger; but by the Letters that came in here this Morning, his Highness is a little better.
