Naples, Nov. 17, N. S. On the 6th Infant an Edict was published for establishing a Council of Commerce in this City: Eleven Persons are nominated Commissioners, and Sig. Finochietti has been fent with the neseffary Instructions to the Levant, to settle Commerce between the Subjects of this Kingdom and those of the Porte. An Officer who is a Native of the Republick of Venice, having been sent from hence with a Commission to raise Recruits in that State, he has upon Discovery been imprisoned there; on Notice of which this Court has written very firongly to the Regents of that Republick, infifting on the immediate Release of the said Officer, and Satisfaction for the Affront of-fer'd to the King of Naples.
