HE Council of Commerce lately established here, is vested with great Powers, and especially to decide as Judges all Disputes that may relate to Traffick by Sea or Land. They propose to improve the Manusactures now carried on in this Kingdom, and to set up and encourage others. The great Dissibility will be to induce a People accustomed to Sloth and Idleness, to relish Work, tho' for their better Maintenance. A Society is formed for erecting a Printing-house in this Capital: And they propose to begin by printing Missals, Breviaries, and other Books for the Service of the Church, with which we have hitherto been surnished by Foreigners. They will for the present make Use of Letter cast at Florence.

Modena, Dec. 24, N. S. The Duke our Sovereign holds frequent Councils with his Ministers for well regulating the publick As-fairs, and particularly for promoting Com-merce. By the Marriage of the Hereditary Prince with the young Dutchess of Massa, the two Dominions being become united the Duke of Modena and the Regent Dutchess of Massa have agreed, and have already set Men to Work, to make a High-Road in the Mountains which separate the Modenese from the Dutchy of Massa and Carrara. That Work is suspended at present on Account of the bad Weather, but will be renewed in the Beginning of next Spring. This will be of great Advantage, not only to the Dutchies of Modena and Maila, but to great Part of Italy. For, Goods may be brought up hither by Water from Venice, Trieste, and Fiume, and be carried from hence by Land to Carrara on the Coast of the Mediterranean, whence they may be fent by Shipping to Leghorn, Genoa, Naples, Marfeilles, and other Ports; from which Ports Goods may in like Manner be conveyed by Sea to Carrara, and thence by Land hither, and fent from hence by Water to the Ports in the Adriatick.

Vienna, Jan. 13, N. S. Yesterday Morning between Eight and Nine a-Clock, the most Serene Archdutches Maria Teresa,

Dutchess of Lorrain and Great Dutchess of Tuscany, was safely delivered of a Princess, which at Six in the Evening was baptized with the usual Ceremonies in the Apartment of his Royal Highness her Consort, by Sig. Paolucci, the Pope's Nuncio at this Court, the Emperor and Empress and the Archdutchesses Marianna and Mary Magdalen present, the whole Court being sumptuously dress'd. The young Princess was presented to the Nuncio for Baptism by the Princess of Tuscany Marianna Lodovica Electress Palatine Dowager, and named Maria Carolina Ernestina Antonia Giovanna Josepha.

Hague, Jan. 15. The States of Holland have been affembled fince Wednesday last, and have before them the extraordinary Petitions which the Council of State was directed to make for the Augmentation of the Land and Sea Force of this State. It is advised from Vienna, that Count Uhleseld is nominated to the extraordinary Embassy, which his Imperial Majesty proposes to send next May to the Ottoman Port; and that, in the mean Time, he is to be continued his Imperial Majesty's Ambassador to the States-General.
