HIRTY Six Officers have been appointed, and are now fetting out for the Coasts of Denmark, Norway and Holstein, to reside there in certain Districts, and to muster and watch over the Seamen who are enlifted for the Service of the Fleet: This is an ancient Establishment, laid aside in the late Reign on the Account of some Inconveniencies, but now restored, upon Experience, as it is said, that for want of some such Inspection, as well as proper Encouragement, the best Sailors continually go off into Foreign Service. M. Bestuches had Yesterday a private Audience of the King of Denmark, to present to his Majesty a Letter with a New-Year's Compliment from the Duke of Courland.
