Ardinal Acquaviva, before the Pope's Death, had follicited and obtained, in Favour of the King of Spain, an Indulto for the levying of Ten per Cent. for five Years successively on the Ecclesiasticks in India, in Consideration of the present War. M. Errigues, in Consequence of the Approbation he had received from the Minhters of State in regard to the Affair of San Marino, has restored the former Liberty to that Republick. As yet Things continue here very quiet. Cardinal Corfini, to gain the Affection of the low Sort of People, has caused large Sums of Money to be distributed among them.

Copenhagen, Feb. 23.
