HE Elector of Bavaria has declared to this Court, that not only his own Troops from Hungary shall perform a Quarantine of fix Weeks, within the Frontiers of Bavaria; but that all the Imperial Troops intended to pass through his Country, shall perform a like Quarantine: which is so strictly executed, that a Battalion belonging to Salm's Regiment, which has not so much as been in Hungary at all, is now

performing Quarantine in Upper Austria.
