### A PROCLAMATION.

GEORGE R. HEREAS Charles Earl of Hopton was duly elected and returned to be one of the Sixteen Peers of Scotland, to fit in the Houfe of Peers of the prefent Parliament of Great Britain, and is fince deceased; in order to the electing another Peer of Scotland to fit in his Room, we do, by the Advice of our Privy Council, iffue forth this Proclamation, ftrictly charging and commanding all the Peers of Scotland to affemble and meet at Holy Rood House in Edinburgh, on Friday the Thirtieth Day of April next, between the Hours of Twelve and Two in the Afternoon, to nominate and choose another Peer of Scotland to fit and vote in the Houfe of Peers of this prefent Parliament of Great Britain, in the Room of the faid Charles Earl of Hopton deceafed, by open Election and Plurality of Voices of the Peers that shall be then prefent, and of the Proxies of fuch as fhall be absent, fuch Proxies being Peers, and producing a Mandate in Writing duly figned before Witnefles, and both Conftituent and Proxy being qualified according to Law. And the Lord Clerk Register, or such two of the principal Clerks of the Seffion as shall be appointed by him to officiate in his Name, are hereby respectively required to attend such Meeting, and to administer the Oathsrequired by Law to be taken there by the faid l'eers, and to take their Votes, and immediately after fuch Election made, and duly examined, to certify the Name of the Peer fo elected, and fign and atteft the fame in the Prefence of the faid Peers, and return fuch Certificate into our High Court of Chancery of Great Britain. And we strictly charge and command that this Proclamation be duly publifhed at the Market Crofs at Edinburgh, and in all the County Towns of Scotland Twenty five Days at least before the Time hereby appointed for the Meeting of the faid Peers to proceed to fuch Election.

Given at our Court at St. James's the Tenth Day of March, 1741, in the Fifteenth Year of our Reign.

GOD fave the King.

The following is the Translation of a Declaration published by the King of Sardinia, in relation to the Eventual Convention lately concluded between that Prince and the Queen of Hungary.

THE Court of Spain had already fufficiently made known to the World, by her whole Conduct fince the Death of the late Emperor, as well in the Declarations made by het to other Powers, as in the Negociation fhe has been carrying on with the King; that fhe had formed the Defign of making vaft Conquefts in Italy, without any Regard either to the known Rights of his Majefty to the State of Milan, or to those of other Princes who have Possefilions there.

It was for this Reafon, that immediately upon the Landing of a Body of Spanish Troops in Italy, which was a Proof that the Execution of fo dangerous a Defign was near at hand, his Majefty caused a Declaration to be made to the Ministers of his Catholick Majefty, importing, that in Case the faid Troops made any Motion towards entring into Lombardy, before their Majefties should have agreed in Form upon such a Treaty, as, in Pursuance of the Explanations that had been given in the Course of the Negociation, might contain the Conditions suitable to the Satisfaction of his Majefty's Rights, to his Security, and to that of the other Princes of Italy, his Majefty would think himself obliged, and was actually determined, to oppose them with his whole Force, and by all the Means that should be possible.

But whereas notwithstanding these repeated Declarations, the abovementioned Body of Spanish Troops did actually begin its March through the Territories of the Holy See, directing its Route towards Lombardy, and is moreover followed by another Body of Neapolitan Troops, and by a second Convoy lately landed at the Port of Spezia, his Majesty found that the exact Time was then come for putting in Execution the abovesaid Declarations.

In Confequence whereof, without prejudicing in the leaft Degree, either on the Part of the King, or on that of the Queen of Hungary, their refpective Pretenfions to the State of Milan; on the contrary, in order to fupport them against, a Foreign Occupation, his Majefty has taken, with the faid Queen, provisional Measures for making



miking in Concert the greatest Opposition poffible to the Enterprizes of the Spanish Troops.

These Measures are of such a Nature, that they leave his Majesty on one Hand in full Liberty of hearkening to, and accepting the Propofals that may be made to him, when they fhall be latisfactory in regard to his Rights, and Sccurity, which he does not feparate from that of the other Princes of Italy; and on the other, her Majesty the Queen of Hungary finds in them a prefent Advantage, in the Defence of her Possefiions, for the Time that this provisional Union shall continue, and such Precautions as may be rely'd on, against all Surprize, and all Damage, in the Case of its ceasing to be in Force.

Florence, Feb. 27. The Spanish Forces of the fecond Convoy began to put themselves in Motion this Day : The first Column are to halt this Night at Pietra Santa, a Territory belonging to the Great Duke; To-morrow at Via Reggio, which Place is dependent on the Republick of Lucca; the 1st of March at Pila, the 2d at Pontadera, the 3d at Empoli, the 4th at Pontealigna, the 5th at Prato, the 6th at Scarperia, and the 7th at Fierenzuola, from whence, the next Day, the 8th, they are to halt in the Bolognese. The first Column is to be followed by four others, which will march fucceffively, leaving only an Interval of one Day's March between each Column; they are to pay ready Money for

every thing, and not to ftop any where. Vienna, March 7, N.S. Upon the Ap-Vienna, March 7, N.S. Upon the Approach of Count St. Ignan with four Regiments of Cavalry and four of Huflars detached from Bohemia, the Pruffians are retired out of Auftria, and the direct Communication between this Place and Budeweifs is free again, by the prefent Lodging of that Body at Waithoven, Hoom, and Retz. The King of Pruffia is faid to be gone to Wifhaw, which lies between Brinn and Olmutz, to meet his Minister Count Podewelz.

Hambourg, March 13. Her Serene High-ness the Dutchess of Brunswick, was, the 27th of last Month, delivered of Prince at Wolfembuttel. The Birth-day of the young Duke of Hol-ftein was celebrated on the 21ft, N. S. with great Magnificence at Petersbourg. The late Regent and her Family are still detained in the Citadel of Riga. Some Part of the Danish Cavalry have reparted the Elbe this Morning, as the Infantry did the 10th Inftant from Stade to Gluckstadt. Bruffels, March 17. The Prince and Bishop

of Liege died fuddenly on the 15th Inftant, in the 82d Year of his Age.
