Moscow, Nov. 22.

Esterday being the Anniversary of the Erection of the Regiment of Guards, Simanoski, her Czarish Majesty, as Colonel, and the Great Duke, Lieutenant Colonel of that Regiment, dined in Publick with all the Officers belonging to the same, and in the Evening there was a Ball at Court. The Frost having set in, and some Snow fallen a sew Days ago, it is said her Imperial Majesty will leave this City about the 12th of next Month, and will celebrate her Name Day at Petersburg on the 18th. Yesterday the Marquis de Botta, Minister Plenipotentiary from the Queen of Hungary, had his Audience of Leave of the Czarina, and proposes to set out in a Week or Ten Days on his Return to Vienna; from whence it is believed he will go to reside at Berlin, as her Hungarian Majesty's Minister at that Court.

Moscow, Nov. 25. Yesterday being the Feast of St. Katharine, and the Anniversary of an Order of that Name, instituted by the Czarina Katharine, Mother of the present Czarina, her Majesty dined in Publick with the Princess of Hesse Homburg, both being dressed in the Robes of that Order. His Highness the Great Duke, dined at a feparate Table with the Gentlemen and Ladies of the Court. In the Evening there was a Concert, a Ball, and an Illumination at Court: There were Illuminations also throughout the City. This Day being the Anniversary of her Czarish Majesty's Accession to the Throne, her Majesty went to Chapel in her Crown and Royal Robes, and heard a Sermon preached on the Occasion by the Archbishop of Novogorod, who made a Panegyrick upon her Imperial Majesty. After the Te Deum was sung, there was a Discharge of the Artillery at the Palace, which was answered by another at the Kremelin. At the same Time a very numerous and magnificent Appearance of the Foreign Ministers, Nobility, and other Persons of Distinction paid their Compliments to her Majesty, and had the Honour to kis her Hand. She then retired into another Apartment, and invested Privy Counsellor Munich, Brother of Field Marshal Munich, with the Order of St. Andrew, and conferred upon him the Office of Grand Master of the Houshold, vacant by the Death of Count Sultikoff. Afterwards her Majesty, dressed in her Regimentals as Colonel of the Guards, dined in Publick with the Officers of the Life Guards; and the private Gentlemen of that Company (confisting of Three Hundred and Twenty) who have the Rank of Lieutenants, had the Honour to dine at a separate Table in the same Room.

Florence, Dec. 15. N. S. The continual Rains that have lately fallen, have caused great Inundations in the Country about Rome, and even in that City the Church, called the Rotonda,

has been for fome Days under Water. Above ten thousand Peasants have been forced to leave the Country, and to take Refuge in the City, where the Pope causes Bread to be distributed to them. Monsieur de Gages has demanded Leave of the Pope to quarter his Army in the City of Bologne during the Winter; but the Ministers of the Queen of Hungary have at the same time infinuated, that in Case that Favour should be granted to the Spaniards, General Truan would not fail to block up the aforefaid City to prevent the carrying of Provisions into it. Upon this Account his Demand has been refused, and the General has been obliged to fend fome Regiments of the Cavalry to the Cattle of St. Peter, and to other Places fituated near Imola. Part of the Infantry is gone to Pianoro, and to other Places towards the Confines of Tuscany, where they are posted in such a Manner as if their Design was to canton there all the Winter ; upon which Account, it has been resolved by the Regency of Tuscany, to reinforce the Garrison

of Firenzuola with another Battalion. Vienna, Dec. 8, N. S. The King of Great Britain having been graciously pleased to advance Thomas Robinson, Esq. his Minister Plenipotentiary at the Court of Vienna, into the Number of the Knights Companions of the most Honourable Order of the Bath; and his Majesty being desirous that he should be Knighted and Invested with the Ribbon and Badges of the said Order in the most honourable and most distinguished Manner, Mr. Robinson applied to his Royal Highness the Duke of Lorrain, Great Duke of Tuscany, by Order from the King his Master, that his Royal Highness would be pleased to perform this Function in his Majesty's Name; the Great Duke agreed to it with Pleasure, and the Ceremony was as follows.

On the 8th of December N. S. being his Royal Highnes's Birth-Day, Mr. Robinson came to Court, and after his Arrival in the second Antichamber of his Royal Highnes, was introduced into the Closet, by his Excellency Count Francis de Stharemberg Great Master to her Majesty the Queen, acting then as Great Chamberlain.

Mr. Robinson made three Bows to his Royal Highness, viz. the first as he came in, the second in the Middle of the Room, and the third immediately before his Royal Highness; when after having made a short Discourse, his Royal Highness put on his Hat, and sat in an Elbowchair of Gold Cloth, placed on a Persian Carpet; and having received from the Great Marshal of the Court, the Essock or Sword of Honour, his Royal Highness touched Mr. Robinson, who was kneeling, three Times on the lest Shoulder with the said Sword, saying these Words, Be you a Good and Honourable Knight in the Name of God.

Afterwards the Great Chamberlain presented to his Royal Highness the Ribbon of the Order

upon a Cushion of Gold Cloth, and his Royal I full of Complaints on the Disorders and Devasta= Highness put the said Ribbon over Mr. Robinfon's right Shoulder, he still kneeling; which being done, he rose up, and having returned his Royal Highness Thanks in a few Words, he went out of the Closet in the same Manner as he came in.

His Royal Highness had appointed the following Ministers to affish at this Ceremony, viz. his Excellency Count Zinzendorf Great Master of the Houshold, his Highness Prince Aversberg Great Master of the Horse, his Excellency Count Francis de Stharemberg Great Master to the Queen, acting then as Great Chamberlain, his Excellency Count Uhlfeld First Chancellor of the Court, his Excellency Count Kevenhuller Great Marshal of the Court, and their Excellencies the Marshals Count Daun and Count Cordoua Captains of the Guard.

Their Majesties the Empress Dowager and the Queen of Hungary and Bohemia, and their most Serene Highnesses the Archdutchesses, were in an adjoining Room, from whence they saw

this Ceremony.

Vienna, Dec. 19, N.S. By the last Advices from the Army in Bavaria, of the 15th of this Month, we hear, that the Troops marched the 13th from Astheim to Ried, where they entred into Winter Quarters upon the 15th. The Troops are still posted on both Sides the Inn, although on the Side of Bavaria there are only fome Croats, fome of the Hungarian Militia, and some Hussars. The greatest Part of the Infantry, with some Regiments of the Cavalry, is on this Side the Inn from Ried to Manfey and Lauffen, upon the Frontiers of Saltzbourg, as also to Schardingen and Passau. The rest of the Cavalry, with the Two Regiments of the Infantry of Lorraine and Neuberg, are Part in the Upper, and Part in the Lower Austria, in the Villages and Barracks, as far as Crems, except the Two Regiments of Caraffe and Cordua, which, with Six Regiments of Infantry, are disposed in the Upper Palatinate, and upon the Frontiers of Bohemia. Prince Charles of Lorrain arrived here last Saturday at Ten o'Clock at Night from the Army with Prince Esterhasi.

Dresden, Dec. 17, N. S. Major Bulaw, Count Saxe's Aid de Camp, is just arrived from the French Army in Bavaria, which he left the 8th: He reports, that Count Khevenhuller was then at Ortenbourg near Scharding, and Prince Charles at Ranshoven near Braunau; that the latter having fent General Trips with a Detachment of fome thousand Men over the Inn, and General Konigsegg to Burckhausen, was embarking on that River his heavy Artillery from before Braunau to transport it to Scharding and The raising this Siege is rather imputed Passau. to the Rigour of the Season, than to the Approach of Broglio's Army, which is by no Means in a Condition to act offensively, and wants both Bread and Forage. M. Broglio himself was then at Dingelfing on the Isler, and had a Detachment at Eggenfelden, and another at Tann; Count Seckendorff was at Marcktel, and Count Saxe near Deckendorff. We hear fince, that the French and Bavarians have formed a great Magazine at Straubing, and were going into Winter Quarters, and that the Austrians intended to cantoon from the Bishoprick of Saltzbourg to that of Pallau, posting such advanced Guards as to watch any new Motions their Enemy may make, either towards Bohe-mia or the Rhine. The Letters from Francfort mention, that they have there received many,

tions committed by the French in Bavaria. There is nothing from Bohemia, but that a small Detachment of French Foragers have been lately defeated by the Austrian Hussars. The French Commissaries, who had bought up considerable Magazines in this Country, and great Quantities of Linnen and Woollen Cloth, and other Necesfaries, as well for the Repairing the Accoutrements of Marshal Belleisle's Troops, as for the Use of those tormerly under Marshal Maillebois, are now felling them off.

Dresden, Dec. 23, N. S. On the 18th, Marshal Belleisle marched out of Prague at the Head of 5000 Foot and 3000 Horse, his Route and Defign are differently spoken of. Some intimate, that he intended to go by Beraun and Pilsen into the Upper Palatinate, and so to join or be joined by Count Saxe, and others that he made towards Egra. There are Letters which fay, that Prince Lobcowitz was at Smetschna, and had so beset M. Belleisle in the Forest of Straschnitz, that he hoped he would be forced to surrender himself Prisoner of War; tho' others' make no Mention of this Circumstance, but intimate, on the contrary, that the French have got two Marches upon the Austrians.

There are now Letters Dresden, Dec. 24. from Prince Lobcowitz himself, who says, that he came up with the French at Strachnitz, had already taken 600 of them, and had Hopes of cutting off their intended Retreat to Egra, they having so much Baggage and Ammunition, that they marched but four Miles the four first Days; what is left at Prague is not yet certain, tho' it. is said not above 1000 Men, besides the Sick.

Dresden, Dec. 25. Prince Lobcowitz pursued the French himself no farther than Strachnitz, but ordered four Regiments of Horse to accompany them to the Mountain of Buchau, and 5000 Hustars to harrass them during their whole Route, which it is thought will be very difficult in the Mountains towards Carlsbadt, especially as we hear that the Austrians have already a Detachment at that Place, as also at Falckenau and Schlackenwerde, and have also ordered the Boors and Huntsmen to defend all the Passes and Defilees against the French. Many of them however will, it is believed, escape, unless the present excessive Cold destroys them. Prince Lobcowitz is return'd to Prague, and has fummon'd the Garrison, from whence an Officer has been with him, but it is not known with what Answer.
