Whitehall, May 29. The following is a Copy of an Order for securing the due Observation of the Marine Treaty with the States General, issued under his Majesty's Royal Sign Manual the 5th Instant, to the Governors of Minorca, Gibraltar, Jamaica, Barbadoes, Leeward Islands, Bermuda, Bahama Islands, Newfoundland, Massachusets Bay, New Hampshire, Nova Scotia, New York, New Jersey, Maryland, Pensylvania, Rhode Island, Connecticut, Virginia, North Carolina, South Carolina, and Georgia.

GEORGE R. RUSTY and Well beloved, We greet you well: It having been represented unto Us, by Our Minister in Holland, that Exception is taken there to that Clause in Our Declarations of War against the Crowns of Spain and of France, whereby it is declared, that the Ships of all Nations, carrying Contraband Goods to the Enemies Ports, shall be liable to Confiscation; under Colout of which, it is apprehended there, that Vessels belonging to the Subjects of Our good Friends and Allies the States General may come to be confiscated, on Pretext of Part of their Cargoes being Contraband Goods, contrary to the express Article of the Marine Treaty, concluded between Our Crown and that Republick, at London, the 1st Day of De-cember 1674, confirmed by subsequent Treaties; Or, that by a larger Interpretation than was meant to be given to the general Words in the faid Declarations, (viz. other Contraband Goods) the Captains and Officers of Our Ships of War, and others, acting under Our Commissions, may make Prize of Dutch Ships and their Cargoes, as well in Europe as in America, upon Pretence of their having on Board Spanish or French Effects, though not Contraband; and it being Our Royal Intention, that the faid Treaty Marine, and all Engagements which subsist between Us and Our said good Friends and Allies, should be most carefully and religiously observed; It is therefore Our Will and Pleasure, and We do hereby authorize and empower you to enjoin all Captains of Ships, to whom you shall grant Letters of Marque, or Commissions for private Men of War, against the King of Spain and the French King and their Subjects, to observe carefully and religi-oully, the said Treaty Marine, and give Se-curity, pursuant to the Tenth Article, for their due Performance thereof: And so We bid you fatewell. Given at our Court at St. James's,

the 5th Day of May 1744, in the Seventeenth Year of Our Reign.

Turin, May 22. Prince Lobkowitz was to move with his whole Army, in three Columns, on the 10th, 12th and 14th Instant, towards Monte Rotondo, where a Bridge on the Tyber was already compleated. By all Accounts from those Parts, there seemed to be a wonderful Disposition in the People of Naples, the whole Country, and even Part of the Army, to revolt and second the Austrian General's Undertaking. These Reports seem, in a great Meas. fure, confirmed by the News we have had from Rome, that the King of Naples and M. de Gages had determined to come forwards and meet Prince Lobkowitz before he enter'd the Kingdom; and to put the Whole to the Fate of a Battle.

Dantzick, May 27, W. S. The King of Poland fetr out this Day from Dresden for War-The King of faw, where it is thought his Polish Majesty will remain all the Summer, and then go to the Dyet which is to be held at Grodno after Michaelmas.

Oudenard, May 29. A Lieutenant Colonel of Hussars, in the French Service, having fuggested, a Method of surprizing this Place to the Count de Saxe, a Body of, 3000 French Hotse, supported by 6000 Foot, said to be commanded by the Count de Saxe in Person, advanced this Afternoon towards this Place, and fired supon sour advanced. Brussels, June 1, N. S. In the Night between the 28th and 29th of May, 2 Body of 500 French Hussars entered the Suburb of St. Martin's at Tournay, and attacked a Party of about 47 Austrian Hussars, who defended themfelves with so much Resolution for several Hours, and retreated from one Post to another with so much Order, as gave Time for their being reinforced by other Parties of their Brethren quartered in the Neighbourhood; after which they attacked and routed the French in their Turn, killed several of them, made some Prisoners, and brought off 20 or 30 Horses.

Brusels, June 5. By a Letter just received from an Officer in Prince Charles's Army, dated at Neckars-Ulm in the Nighbourhood of Hailbron, May 26. we hear, that the Prince's Army consists of 72000 Men'; that they have only 230 fick in the whole Army; that the Prince is adored by his Troops; that there is a persect Harmony between his Highness and all the Generals; and that the Army would begin to march on the 28th of May towards Mayence.

Brussels, June 54 On the 2d Instant the Confederate Army, confisting of the English, Hanoverian, Austrian and Dutch Troops, under the Command of Marshal Wade, the Duke of Aremberg, and Count Maurice of Nassau, began to march from their Camp at Aiche towards Oudenard. Menin is belieged in Form. On the 1st Instant the Cannon began to play from the Ramparts upon the Besiegers, and last Night it was faid, that the French having found more Difficulty than they expected in their Approaches, on Account of the Inundations which have been made about the Town, had begun to bombard the Place, in Hopes of obliging the Governor to surrender; and that a Part of their Army is employed at the same Time in draining the Inundations.

Hague, June 2. We have now certain Advices, that the Siege of Menin is actually begun and carried on with all possible Vigour. The Trenches were opened the 28th or 29th past. It is faid that there are three Attacks, and that M. Fenelon commands one of them. As to the Progress of the Siege, we hear that the Gar-tison kept a constant and brisk Firing, and that the French have transported some of their Wounded to Lifle. We also hear, that the Confederate Army was to march on the 1st Inflant by Way of Ninove towards Oudenard, whither the Duke d'Aremberg had fent a De-This last Place is said to tachment before-hand. have been in fome Danger of being surprized by a large Detachment of Count Saxe's Corps, which appeared unexpectedly before it; but by the Vigilance and good Countenance of the Garrison, they thoughte fit to abandon the Enterprize with Loss of an Officer and a few Men.

Hague, June 5, N. S. By Letters of the 3d of June, from Flander, we hear, that the Confederate Army was then encamped behind Oudenard, and that the Siege of Menin continued without any remarkable Incident on either Side. It is faid that Prince Charles, with his whole Army, passed the Neckar at Neckars-Ulm on the 31st past. We hear that Prince Lobkowitz was, on the 14th past, advanced to Citta Ca-

stellana, and the Spaniards and Neapolitans not far from the other Side of the Tyber.

Ghent, June 2, N. S. The French Parties which infested the Neighbourhood of Dixmude, and the Canal from hence to Bruges, retired some Days ago to Harlebeck and Courtral; but they are since returned in greater Numbers, which has obliged the Duke of Aremberg to reinforce our Hussars with two Regiments of Dragoons and six independent Companies, in order to secure the Frontier of Flanders from their Depredations; and we have demanded from the Chatellenie, or Lordship of Lisse, the same Number of Rations which the French demanded from the Districts of Ypres and Dixmude, under Pain of military Execution.

Extract of a Letter from Ghent, June 4, N.S.

Upon the 31st of last Month, six Hundred Men, and as many Horses, just arrived from England, were expected from Bruges. French having had Intelligence thereof, march'd, to the Number of four Thousand Men, near to the Village of Bellem, by the Canal of Bruges, into the Wood called the Jesuits Wood. General Campbell had that Morning detached an Hundred and Fifty Men from Ghent to meet the Recruits, and they being informed of that Ambuscade, went on, and having met the Men and Horses in Question, about an Hour and Half's March from Bruges, they entred together with them into that Town. Thereupon the greatest Part of the French retired, and the Remainder was attacked Yesterday Morning by the Scotch Highlanders, who killed two and thirty of them. General Campbell fent out another Detachment to conduct the rest of the faid Recruits, and to see whether the Enemy were returned or not, and whether they had not a Bridge upon the Canal; but there is now no farther Danger, the British Recruits being all arrived here this Day under the Command of Major General St. Clair, with the Loss of one Horse only, which died at Sea.

Amsterdam, June 5. The eight Men of War of the Squadron of this Town, appointed for the Assistance of his Britannick Majesty, have now got over the Pampus; their Artillery, Provisions, and every Thing else that is necessary to enable them to put to Sea, will be sent to them in the Texel.
