Bern, December 5, N.S.

HE late Governor of Fribourg is summoned to Vienna, and is gone thither to give an Account of his Conduct; and the French have already begun to undermine, in order to level with the Ground the Fortifications both of the Town and Castle.

Bern, Dec. 12. On the 4th Instant the Great and Little Council of this City were extraordinarily assembled, upon a Letter from the States General to the Canton of Bern in particular, desiring an Additional Number of 2400 Men, in virtue of the Alliance of 1712; and Yesterday the Debate thereon was resumed, and lasted from Eight in the Morning till Three in the Asternoon, when the Augmentation was agreed to.

Petersbourg, Dec. 8. This Day the Right Hon. the Earl of Hyndford, his Britannick Ma-

jesty's Minister, arrived here.

Florence, Dec. 8, N. S. The Spanish Troops remain in the Towns of Foligno, Asfiss, and Perugia, in which they intend to fix
their Winter Quarters: The Austrians winter in
Fano, Pesaro and Rimini. The Grand Duke's
Troops are partly returned to Florence, in order to repair to Prato, and the rest are returning
into their ancient Garrison of the Capital, being
actually in March for that Purpose. General
Brettewitz is expected this Evening from Arezzo.
The Spaniards have given Assurances to this Regency, that they will scrupulously observe the
Neutrality as to Tuscany.

Oporto, Dec. 15. We hear from Galicia, that a Draught of 25 Men per Company hath been made from the Regiment of Lisbon at the Groine, and that they are directed to hold themfelves ready for the first Orders, which it was generally believed would be to march to Barcelona, in order to proceed to Italy, as no Ships appear for their Transportation: That the Captain General had issued the necessary Orders for levying every fifth Man, which was executing with great Strictness, and occasioned so much Uneasiness, that Deputies had been sent to Ma-

drid to remonstrate to the King, in the Name of the Province, the deplorable Condition to which it would be reduced by the draining it of so many of its Inhabitants, at a Time when it was loaded with Taxes to an insupportable Degree, and had parted with such a Number of Men as it had already given since the Commencement of the War.

Vienna, Dec. 19, N. S. By the last Letters from Silesia we learn, that General Keil was with 4000 Foot at Oderburg waiting for the Insurgents, of whom a Body of 2 or 300, at a little Town called Pleiss, have been made Prisoners for Waht of a proper Discipline on their Part, and through the Intelligence which the Prussians had with some Sectarys of all Sorts, which the King of Prussia had settled in that Place. The Hungarians had not so much as an ordinary Guard at the Gates of the Town, when the Prussians were let in by the new Inhabitants abovementioned.

Vienna, Dec. 22, N. S. A great Body of Prussian Troops being come from Silesia by Greissenberg and Friedland, to disengage the Garrison of Prague, the Chevalier de Saxe was no longer in a Condition to hinder their Escape. The Ulans however took a great deal of Baggage, as also six Cannon from them, and made about an Hundred Men and Ten Ossicers Prisoners. Above a Thousand Deserters came to the Chevalier de Saxe's Camp, where it was reckon'd that not a Third of the Garrison of Prague gained the Frontiers of Silesia.

Vienna, Dec. 22, N. S. General Berenclau is Master of the chief Posts upon the Danube. We are intent here on saving the Empire, which is under the most horrible Oppression. The Prussians are incamped in Silesia, between Grotkaw and Olali, near Breslau, and the Prince lies with his Army at Liegenhalls. General Marwitz is retired from Troppau and Jagendorst towards Ratibor to join the King. We have Upper Silesia free. The Insurgents are at Odersberg.

Vienna, Dec. 26, N. S. The Prussians, to the Number of 4 or 5000, from Monsterberg, having attempted to dislodge Colonel St. André,

who is with two Battalions at Patzkaw, a little fingle-walled Town between Otmakaw and Warta upon the Neisse, they were repulsed, and General Luchasi coming up with some Cavalry, and a small Body of Infantry, pursued them to this Side of the River over-against Otmakaw.

Warsaw, Dec. 23, N.S. Last Night arrived an Express, with an Account, that on the 15th Instant General Nassau, with a Corps of about Ten Thousand Men, Sixteen Cannon, and a Hundred Boors, with Hatchets and other Implements to repair the Roads, marched from Greissenberg in Silesia through the Circle of Queiss in Upper Lusatia, without any previous Requisition, and on the 16th joined the Prussians from Prague at Friedland.

Extract of a Letter from the Head Quarters of the Cantonment at Neustadt, Dec. 23, N.S.

Our Army having marched from Oppotichna in three Columns, and being come out of Bohemia, after having left a large Body of Troops and the Saxons in Winter Quarters there, and his Highness the Prince having sent a considerable Reinforcement into the Upper Palatinate, we are at last arrived here in Silesia in the Neighbourhood of Neiss, which City we have blockaded. Upon our Approach the Enemy, to the Number of 10 Battalions and 15 Squadrons, have abandoned Troppau and Jagendors, and it appears that they will be forced to abandon Ratibor likewise; after which we shall quit our Cantonments, and take Winter Quarters.

Berlin, Dec. 26, N. S. His Prussian Majesty returned hither Yesterday from Silesia.

Hague, Jan. 8. N. S. M. de Dieu has taken his Leave of their High Mightinesses this Morning, and will in a few Days begin his Journey to Russia. Since last Post we have learnt that the Elector of Cologne's Commissary was arrived at Maestricht, and that the first Division of the Dutch Troops under Major General Mattha set out from the Meuse for the Rhine on the 3d Instant. The Mortality amongst the Horn Cattle in these Provinces, but especially in Holland, begins to grow a most grievous Calamity, and if it continues to rage a few Months longer with the Violence it does at present, the whole Plat Pais is threatned with being laid Waste.

Hague, Jan. 12. We have Advice from Liege, that the French are forming a very large Magazine of all Kinds of Military Stores at Givet; and particularly, that they have laid up no less than 3000 Waggon Loads of Charcoal under the Cannon of that Fortress, which looks as if they thought of making Use of hot Bullets in some Siege in that Neighbourhood.
