Petersbourg, December 29.

IS Imperial Highness the Duke of Holstein having been taken ill upon the Read of the Small Pox, at a Village which lies nearer Moscow than Petersbourg, the Empress immediately, upon the Receipt of this disagreeable News, sat out for that Place, and her Majesty's Return is uncertain; however, his Highness is thought to be out of Danger, his Small Pox being a very favourable Sort.

Vienna, Jan. 9, N. S. The Prussians have abandoned Opelen; but are still Masters of Kosel, where the regular Fortifications, intended by the King of Prussia, are not perfected; but are in such a Forwardness as to demand the Employing of Cannon to dislodge the Garrison.

Vienna, Jan. 11, N.S. The King of Poland is expected as next Sunday at Olmutz, for which Place Count Buneau his Minister intends to set out on Thursday next, and the Great Duke on Saturday, attended by Count Kinski, as Chancellor of Bohemia. Every Thing is prepared for making his Polish Majesty's Pallage as safe, expeditious, and commodious as is possible.

Vienna, Jan. 11, N.S. Prince Charles is still here. General Thungen is recalled from the Army in the Palatinate, to take the Command of the Postirung or Cantonment of the Austrian Troops in Silessa, which extends itself through Glatz to the Oder. The old Prince of Anhalt Dessau is said to be assembling Troops at Streelen and Henrichaw; and it is industrioully given out at Brellau, that upon the Conclusion of a Treaty between Prussia and Russia, which is pretended to be hourly expected, Bohemia and Moravia are to be invaded anew. General Berenclau has cleared the Upper Palatinate as high as Stadtamhoff and Ratisbonne, and General Thungen's Corps, (which will be commanded by General Tawn) is advancing, so that the French and Bavarians will have the latter in Front, and the former in their-Rear.]

The Corps under these two together make 40,000 Men without Recruits; and when compleated, will exceed 50,000. By our last Advices from Silesia, the Austrians have found great Numbers of Recruits there, and the King of Prussia has demanded 30,000 Horses to remount his Cavalry. Prince Lobkowitz is to be recalled from Italy: The Army there in the Spring

will be compleated to 32,000.

Vienna, Jan. 16, N.S. An Adjutant General is arrived here with Advice of the Defeat of 700 French Foot, who with 200 Bavarian Horse were in March to throw themselves into Amberg. The Bavarians fled immediately upon the Approach of the Austrians, and the Foot belonging to Marshal de Saxe's Regiment were all killed or taken Prisoners. General Thungen proposed to attack Amberg the next Day, or to advance against a Body of 15000 Men which are said to be in March from Kelheim; as no News is arrived fince, it is supposed that he is gone to meet, or is waiting for the Enemy. 11 is now confirmed that the old Prince of Dellau has passed the Neiss with 42 Battalions and 18 Squadrons, whereupon Marshal Traun is assembling his whole Force at Jagendorff, but which is by no Means equal to that of the Prussians. The worst however that is seared is the Loss of the Flat Country, and of such advanced Posts as Paschgau, Ziegenhals and Neustadtsle. Count Buneau set out on Thursday last, and the Great Duke with his numerous Court fet out this Morning for Olmutz, where the King of Poland will arrive To-morrow in the Evening. The Bishop of Olmusz is chosen Archbishop of Saltzburg.

Vienna, Jav. 20, N.S. The Prussians who are advancing in Upper Silesia, and who are said to be composed of 42 Battalions and 18 Squadrons, are not supposed to make a Body of above 24,000 Men. They have no Baggage not great Artillery, and having brought with them too empty Waggons, which are, it is thought, defigned to fetch Wood in particular, amongst other

other Necessaries, for the Service of the Garrison of Neiss. Marshal Traun however has retired to Pensch within the Mountains to the Lest of Jagendorss. Within these eight Days that the Prussians have been in Motion, no less than 2500 Deserters have been received by the Commander in Chief of the Insurgents. The Commandant of Amberg having resuled to surrender, General Thungen, to employ the four Days that he was to wait for more Artillery from Passau, blocked up Amberg, and advancing to Neumark, took that Place upon the 15th.

Vienna, Jan. 23, N.S. Prince Charles returned on the 21st Instant to the Army in Silefia, to see if he can remedy the Mischief occasioned by the Retreat from Jagendorff. It is thought his Highness will not be absent above eight Days. During the Time he was here, he did not appear in Publick, nor was accessible to the Foreign Ministers. It is reported, that M. Segur is retiring from Kelheim into the Bishop-

rick of Aichstadt.

Copenhagen, Jan. 16, N. S. An Ordonnance, dated the 31st of December 1744, is just published here, prohibiting the Wear of all Ribands, Palatines, Women's Handkerchiefs, &c. that are worked with beaten Gold or Silver, and brought from Abroad. Every Thing made with Gold or Silver Thread was prohibited before.

Copenhagen, Jan. 19, N. S. Towards the latter End of November last, a Ship belonging to Amsterdam was brought by ten or twelve French Men, detached from a Privateer of Dunkirk, into Swinoe, an Out-Port about two Leagues from Mandal. And it is confidently said, that the Commander of that Detachment had declared, that they had Orders to take and molest all the Dutch Ships they could meet with.

Copenhagen, Jan. 26, N.S. We hear from Russia, that the Empress has ordered a great Body of her Troops, to the Number of 60,000 Men, to put themselves in Readiness to march

next Spring.

Hambourg, Jan. 19. We have just received Advice, that the Queen of Hungary's Ambassador, Count Rosenberg, has dispatched a Courier to Vienna with the important News, that before the Russian Court lest Moscow, Orders were assumed for assembling the different Corps of Troops, which are quartered in the conquer'd Provinces, along the Baltick, and in the Ukraine, together with a Body of 17000 Cosacks; all which are to hold themselves in Readiness to march upon the first Orders, with a proper Train of Artillery, and that Magazines were preparing for them at Riga, Kiow, and Smolensko. M. Heinzen has received a Rescript from his Court with the like Information.

Hambourg, Jan. 22, N. S. The Respite which the Directors of the French East India Company have asked to deser the Payment of

the Dividend due the 1st of this Month till next October, at a Time when that Company has suffered no visible Loss, makes the Persons con-

cerned in it here very uneasy.

Hambourg, Jan. 29, N. S, By Letters from Petersbourg of the 1st Instant, O. S. we learn, that his Imperial Highness is not thought to be in any Danger. The Princesses of Zerbst are arrived there. We hear the Princess of Sweden has instituted an Order which is called the Order of Constancy, and that her Royal Consort and Count Tessin have received it from her Highness, as have likewise the Ladies of her Court. Early on the 27th in the Morning an Estasette passed through this Place for the Court of Denmark, with News, that the Emperor died at Munich on the 21st.

Dresden, Jan. 20, N.S. We have Advice here, that the Prince of Anhalt Dessau passed the Neiss upon the 9th Instant with a Corps of about 30,000 Men, in order to drive the Austrians from their Posts, but we do not yet hear of

any Advantages he has obtained.

Hague Jan. 26, N.S. By our freshest Advices from the Lower Rhine, the Dutch Troops under Lieut. General Smissaert, had taken up their Quarters for the present in the Archbishoprick of Cologne, in Nuys, and the neighbouring Villages. Major General Constant, with the Regiments from the Side of Zutphen, was likewise arrived upon the Rhine over-against Ordingen. Marshal Maillebois is said to continue reinforcing himself upon the Lahn; and General Sommerfeldt, with M. Smissaert, were repairing to Cologne, to confer with Lieutenant General Wengen, in order to prepare every. thing against the Arrival of the Duke of Aremberg, who was expected by the 24th Instanta The Austrians in the Upper Palatinate seem to push their Operations very successfully. Am-, berg, if not furrendred, is at the last Extremity; and it is certain that the Queen's Troops have made themselves Masters of Neumark, and taken its Garrison, consisting of 1500 French; Prisoners of War. The Prince and Princess of Orange were expected here as To-night or Tomorrow, in their Return from Breda to Friseland; but their Highnesses have deferred their Journey for a few Days on account of the Rigour of the Season.

Hague, Jan. 28, N.S. By Advices from Francfort and Cologne we are inform'd, that his Imperial Majesty Charles VII. Elector of Bavaria, had been seized at Munich, on the 20th Instant, about Ten o' Clock at Night, with a Fit of the Gout in his Stomach, of which he

died after a few Hours.

Hague, Jan. 29, N. S. By our freshest Letters from the Lower Rhine, General Sommerseldt, the Lieutenant Generals Smissaert and Wengen, and Major General Paoli, were at Cologne, waiting the Arrival of the Duke

of Aremberg, who took up his Head Quarters on the 25th Instant at the Castle of Boeckum near that Place. Letters from Petersbourg of the 29th past, O. S. say, that the Small Pox was come out very favourably, tho' full, upon the Great Duke, and that three Days had past after the Eruption, without any bad Symptom, tho' his Imperial Highness suffer'd greatly from the Inclemency of the Season, in the wooden Hutt he had been obliged to take up with upon the Road in a Village callest Scholetoway. Letters from Spain confirm the Arrival of Admiral De las Torres, but say it is only with a Part of his Fleet, and two Ships with the Treasure on board, and mention the Groin as the Port he has made. M. Aylva set out this Morning to join Mr. Burrish at Bonn; but M. de Dieu is not in a Condition to travel. M. Tron, who has refided here for some time on the Part of the Republick of Venice, is upon the Point of quitting the Hague, being named to succeed M. Cornaro, as that Republick's Ambassadour at Paris. It is talk'd here, as if General Segur, with the Corps of French Troops under his Command, was making Preparations to leave Bavaria upon the Death of the late Emperor.

Helvoetsluys, Jan. 31, N.S. This Day at Two o' Clock in the Afternoon arrived here his Excellency the Earl of Chestersield, who sailed from Harwich Yesterday at Ten of the Clock

in the Morning.

Hague, Feb. 2, N. S. Yesterday Noon the Right Hon. Philip Earl of Chestersield, his Britannick Majesty's Ambassador Extraordinary and Plenipotentiary to the States General, arrived here. Count Saxe has lately had an Apoplectick Fit at Paris, and is thought to be in a dangerous Way. There are concurrent Reports here from several Quarters, (though not certainly known to be true) of the young Elector of Bavaria's having discarded Count Thoring, and put himself into the Hands of M. Preysing and Seckendorff, and declared by the Canal of the latter to the Queen of Hungary, that he pretended to take no Part in his late Father's Quarrel, and hoped the Queen would discontinue Hostilities against Bavaria. We hear from Paris of the 25th, Ithat the Toulon Squadron was still in the Port of Cadiz.

Portsmouth, January 23. This Day Rear-Admiral Medley arrived at Spithead, from cruizing in the Soundings, with the Squadron of his Majesty's Ships under his Command, and two Dutch Men of War. They brought in a French Ship from Martinico laden with Sugar, Coffee, Cotton and Cocoa, of 250 Tuns Burthen, which was taken by them.
