THE Prussian Troops in Silesia are entered into Winter Quarters. The Reigning Prince of Dessau commands the Army which is in Lower Silesia, and he has fixed his Head Quarters at Schweidnitz. As Prince Leopold his Son is fallen sick, the Margrave Charles received Orders the Day before Yesterday to repair to the Army which is in Upper Silesia, in order to take upon himself the Command thereof. It is reported here, that the said Margrave will shortly espouse the Daughter of the Landgrave Maximilian of Hesse. General Mortagne, who commands the French Auxiliary Troops in Bavaria, is arrived here; and M. de Courten, Colonel of a Regiment of Swiss in the French Service, is expected here soon. By Advice from the Empire, Count Seckendorff had, before the Death of the Emperor, demanded and obtained his Dismission, and was gone to Augsborg in the Way to his Estate in the County of Altenbourg in Saxony.
