In the mean Time tachment, which they left to secure their Baggage at Hochst, it was thought they would draw together, and canton at Trebur; but they appear now to have altered their Intention, for they are forming a Line on the other Side of the Mayn from Griesheim to Aschaffenburg, with 28 Battalions, which however are but half compleat: The rest of the Troops are disposed in two Lines, so that they occupy all the Places on this Side of Darmstat, particularly Allheiligen, Griesheim, Gottelar, and Erfelden. They give out, that they are soon to be considerably reinforced, and that Marshal Maillebois intends to dispute with the approaching combined Army the Passage over the Mayn, and with this View is to remove his Head Quarters from Worms to Gerau. But as they have laid three Bridges over the Rhine at Rhine-Turkheim, and on the 19th removed their Hospital from Hochst first to Trebur, and the next Day over the said Bridges to Worms, it is generally believed, that upon the combined Army's approaching the Mayn, they will not face them, but retire on the other Side of the Rhine, the rather as the Territories of Darmstat are so exhausted, that they can furnish nothing for sublisting an Army, nor can they be supplied with Necessaries from Franconia by the Mayn, by reason of the Ice. They have indeed, notwithstanding this Obstacle, brought together 20 Vessels, which with Difficulty passed by this City on the 25th Instant, for Hochst, and with which, as they give out, they will form a Bridge for repassing the Mayn.

Francfort, Feb. 27. The French still give out, that they expect from the Brisgau and Suabia a Reinforcement of fix Battalions and twelve Squadrons, and another from Lorrain of fifteen Battalions and twelve Squadrons, after the Arrival of which, they will make Head against the Allied Army.
