Berlin, March 13, N.S. They begin here to make great Preparations for War. All the Recruits they have been able to raise, are filing off towards Silelia, as well as the Grenadiers of the Regiments which are here in Garrison; they cast Cannon, and make a Number of Iron Mills, and all the Dispositions seem to forebode a vigorous Campaign. His Prussian Majesty, who arrived in Town on Tuesday last, the 10th Instant, continues in the Resolution of setting out the Day after To-morrow for Silesia; and several of his Domesticks and Baggage set forwards Yesterday. His Majesty did not honour the Feast, which the Marquis de Valori gave the Day before Yesterday, on Occasion of the Dauphin's Marriage, with his Presence, but the Queen and the rest of the Court were there.

Hague, March 19. Marshal Maillebois, reinforced by the Corps of M. Lowendahl, found
means to pass the Mayn at different Places with
all his Troops, which are said to amount to 48
Battalions, and 60 Squadrons, between the 9th
and 12th instant. The Position of the Allies
was such, that it was thought adviseable for them
to retire behind the Lahn, the better to form and
maintain themselves. This Retreat however
was not effectuated, without the Loss of a small
advanced Detachment of Hanoverians, which
had been posted at Cronberg, who were obliged
to surrender themselves, as is written from thence,
Prisoners of War, on the 14th instant.
