R. Burrish, his Britannick Majesty's Minister to several Princes and Circles of the Empire, arrived here in the Night between the 12th and 13th Instant, attended by an Escort of Austrian Hussars, and the next Day had his first private Audience of his Electoral Highness our Sovereign, to which he was introduced by the Count d'Elts, Great Chamberlain to that Prince, after which Mr. Burrish dined with the Elector in Publick. M. d'Aylva, Minister from the States-General, is expected here every Day from Bonn. Some Days ago, as a Party of French were preparing to pass the Rhine in four or five Boats, and land in the Rhinegow, a Number of Peasants got together, and fired upon them, which obliged the French to retire; but none of their People were either killed or wounded. M. Maillebois immediately required Satisfaction for this Affront; whereupon the Elector order'd 15 of the Peasants to be taken up, and the Matter having been examined into, three of their Chiefs were condemned to Imprisonment and hard Labour for a Year; but now the French General has fent to demand those three Men, in order to hang them up in the Face of his Army. He also requires, that the Elector should immediately give up his little Fortress of Konigstein to be garrison'd by French Troops, and that his Highness likewise should instantly furnish upwards of 800,000 Rations for the Use of the French Army. The Elector having received these Demands, immediately sent Count Ingelheim to expostulate with the Marshal upon the Unreasonableness and Cruelty of them; but that Gentleman returned Yesterday Morning from Hoechst, without having obtained the least Mitigation of them; upon which his Electoral Highness has declared to the Marshal, that his Subjects of the Rhinegow having been condemned, by the Law of his Country, to a Punishment adequate to their Indiscretion, he did not think himself at Liberty to give them up to the Marshal's Resentment: That his Fortress of

Konigstein was garrison'd by his own Troops, who should observe a strict Neutrality between the Powers engaged in this War; and with respect to his Demand of so great a Quantity of Rations to the French Army, that his Subjects having furnished so much to them during the Winter, the Marshal ought to know very well, that it was impossible for the whole Country to supply what he now demanded, and that he was Master to take all that he could find.

Hague, March 26. Marshal Konigsegg has taken his Leave of this Place To-day, and is to set out for Flanders, whither the Prince of Waldeck and Lieutenant General Sir John Ligonier propose to follow him the Beginning of next Week.

Captain Frankland, Commander of his Majesty's Ship the Rose of 20 Guns, being, on his Way to cruize between the Roques, Cape-Flor rida, and the Pan of Matanzas, on the North Side of Cuba, about 35. Leagues to the Westward of Havana, on the 21st of December just before Day-light, found himself almost on board a large Ship, of which he was to windward, and a-stern withal; Captain Frankland kept his Wind till Day-break, then found she had but one Tier of Guns, but was full of Men by her Working; for before the Captain shewed his Colours, she had run her Courses up, bunted her Mainsail, and had every thing ready to engage, her Decks being crowded with Péople. About Seven in the Morning they began an Engagement, which lasted until half an Hour past Twelve. was a fresh Gale and a great Sea, notwithstanding which they were along Side each other three or four Times. Before the struck, the had near 100 Men killed out-right, and four of her Guns on one Side disabled. She is called the Conception of St. Malo, Adiran Mercan, Master, bound from Cartagena to Cadiz, but was to touch at Havana, to land upwards of 200 Seamen, besides Officers. The Rose had only five Men killed, and about 10 or 12 dangeroully wounded, including the Master, and several flightly. The Cargo of the Prize consists of Hides, and Cocoa, with 70 Chests of Gold and Silver, containing about 310,000 Pieces of. Eight. She had feveral Pailengers on board, from whom they got about 5000 Ounces of Gold, in Doublons, Pistoles, Bars, &c. The Rose had on board but 177 Men, Officers and Boys included. He has carried the Prize into South Carolina
