Y the last Accounts we had from Prince Lobcowitz we hear, that he has fixed his Camp at Foss Alta on this Side the Panaro. By this Position, by Nature very strong and favourable, he covers Modena, the Mirandola, as well as his Communication with the Po and Mantua, from whence by Degrees some Recruits begin to join his Army; and his Situation at present is such, that it is very much questioned whether M. de Gages will dare, or is strong enough to attack him. The three Battalions, which the King of Sardinia fent from Piedmont, are got sase into Modena; and at the Austrian General's Request, a Regiment of Horse quarter'd at Placentia was immediately ordered to march to his Army, and is supposed to have joined it Yesterday Evening. It is hoped that this Reinforcement, together with the Regiments of Pallavicini and Clerici and Warassiners that were in Lombardy, and about 2000 Recruits from Germany already arrived at] Prince Lobcowitz's Camp, will enable him to [make a Stand, and to maintain the advantagious Post he has fixed upon. M. de Gages has not as yet any of his large Artillery, and confequently cannot attempt to besiege any of the Places. As far as we can judge of his Plan fince probably march as foon as his Cavalry from Savoy, which is to be at the Var on the 20th, is once entred into the County of Nice. It is faid that last Night Orders were issued and sent to above twenty Battalions of the Sardinian Troops to march to the Posts assigned them towards the Genoese Frontiers, in order to give all posfible Opposition to the Enemy; and it is thought the English Squadron will greatly molest and distress Don Philip's Army in their March by the Rivera. Capt. Ambrose some few Days ago took, funk or destroyed seven of the Enemy's Vessels laden with Arms, Stores and Provisions near Port Maurice. On the 15th Instant, being Holy Thursday, Marquis d'Ormea was suddenly taken ill at Church, and carried

Home, as was thought, dying; but he is at present considerably better.

Vienna, April 24, N.S. Since the Arrival of General Serbelloni, accompanied by fix Postillions, on the 20th Instant, with the News of the Deroute of the French and Palatins at Plaffenhoven, Colonel Odonnel has brought the following Particularities, viz. That the Loss of the Enemy was much greater than was imagined at first, the killed and wounded exceeding 3000, besides 800 Prisoners, and great Numbers of Deferters; so that it was presumed, M. Segur, who was march'd to Fribourg, would not reach that Place with more than 3000 of his Countrymen: That General Segur was wounded in the Head, but able to keep on Horseback: That the Palatins too were gone off, and, as was supposed, to Heidelbourg or Manheim: That a great Quantity of Bread, just baked, was found at Rain; with a confiderable Magazine of all Sorts of Stores: That the Hessians were in the meant while at Fridberg, and the Bavarians under the Cannon of Augsbourg.

Upon the 17th General Trips obliged the French Garrison at Rain to retire towards the Lech, leaving behind them a confiderable Magazine: The Enemy then posted themselves at the Head of the Bridge, endeavouring to maintain themselves there, but General Trips having advanced towards them, and the Warasdins having already begun to pull up the Pallisadoes, they were ob-. liged to abandon it, and to pass the Lech under Favour of their Cannon, which was planted on the other Side that River. Thereupon General Trips took Possession of the Bridge, so that the Enemy had only Time to take up a few Planks on the other Side: They then retired towards Donawert,

Donawert, where having learnt that a Detachment of our Hussars were advancing on the other Side the Danube, they broke down the Bridge, threw their Ammunition, together with fome Pieces of Cannon, into the Water, and fled from thence in the Night towards Lavingen. The Bavarians and Hessians, on their Part, marched on the 16th towards Fridberg, but they were fo harraffed by the Corps under the faid Prince Lobkowitz, that the Bavarians passed the Bridge of the Lech with all Diligence, and let Fire to it after them, retiring towards Augsbourg. But the Hessians separated themselves from them on this Side near Fridberg, and remained on this Side the Lech, declaring themselves Neutral. We found two Pieces of Cannon and one Carriage, which the Enemy had left behind them in their forced Retreat.

Dresden, April 28. We just now hear that the Peace is signed between the Queen of Hungary and the Elector of Bavaria, and that it was published at the Head of that Prince's Army, by the Prince of Saxe Hilburghausen, on M. Thoring's refusing to perform that Ceremony.

Mentz, April 29. The Prince of Conti passed by this Town Yesterday Morning, and dined with the Prince of Nassau at Biberich; but we do not yet learn where his Highness will fix his Head Quarters. In the mean Time it is certain, that the French have summoned the Commissaries and Bailiss of the Electorate of Treves to meet immediately at Simmeren (fituated in the Palatinate, almost equally distant from Mentz, Coblentz and Mont Royal) and demanded 200,000 Rations to be furnished at that Place. The Elector of Bavaria returned to Munich-on the 24th, and the Peace was to be proclaimed in both the Armies on the 26th. We just hear, that the French have forced 2000 Peasants out of the Rhinegow, to work with all possible Diligence to fortify the Head of their Bridge at Biberech. The Prince of Conti lay last Night at Wisbaden, and it is given out, that his Head Quarters will be at Swolbach. The French talk openly of passing the Lahne, and attacking the Allied Army.

Mentz, May 2. The Prince of Conti has taken his Head Quarters at Swolbach, and, it is faid, the French Army will encamp in a Day or two. We have Advice that the French have brought about 20 heavy Cannon, and 20 more rof a smaller Calibre, with a proportionable Quantity of Ammunition to Spire, and 'twas given out that this Train would be brought immediately to Worms, where Directions were illued for assembling a great Number of Horses; but those Orders have been since countermanded. General Hagenbach, who commanded in the Castle at Fribourg, passed through this Town two Days ago in his Way to Aix la Chapelle, and reports, that the French upon the Neckar, after having assembled all the Forces they had in the Circle of Swabia, do not amount to 15000 Men. Qur Elector has received requisitorial Letters from the Prince of Hesse, for the Passage of his Troops, now upon their Return from Bavaria, who are said not to exceed 4000 Men.

From the Camp at Cambron, May 6. The Allied Army arrived here from Soignies Yesterday, and will march To-morrow to a Camp marked out about a League on this Side Leuse, where the French have these three Days past had an advanced Party. The Reports of Deserters vary about the Progress of the Siege of Tournay; there are four Attacks, but the real one is that at the Gates of the Castle.
