Genoa, May 29, N. S. The Cavalry of the Spanish Army, under the Command of M. de Gages, advance very flowly, being with Part of the Infantry at Rapallo and the other Villages between that Place and this City, where they, halt, until they have consumed all the Forage, to prevent the Austrians from following, by depriving them of all Hopes of Sublistance. Some small Parties arrive daily in the Bisagna, and march over the Hills into the Polcevera, where they have seized all the Passes and Avenues that lead to this City, stopping and visiting all Persons that come in or go out. Hitherto the Troops observe a strict Discipline, and pay for what they want. The Commissaries are endeavouring to contract for drawing the Train of Artiliery up to Tortona. Yesterday arrived two large Barks from Naples, each having three Pieces of Cannon and three Mortars, with all the mecessary Ammunition. These two Vessels were in Company with another likewise loaden with warlike Stores, from whom they separated three Days before. The Letters from Naples received this Morning, mention the Departure from thence of 15 Vessels, all loaden with Artillery and Stores. The Vessels loaden with Ammunition from Barcelona, which were got to Monaco, have been ordered for their greater Safety to return back to Villa Franca, where they now are with the three French Men of War, expecting four others that are fitting out at Toulon, which, It is faid, are to be joined by a Squadron of eight Gallies from Marseilles. The 23d Instant Prince Lobcowitz decamp'd from Parma with 14 Regiments of Infantry, and seven Regiments of Ca-1 valry and Hustars, besides a Body of Lycaneers, I and are marching towards Tortona, where he

will halt to observe the Motions of the Spanish Armies in this State. It is reported, that upwards of 10000 Men of Regular Troops and Recruits are arrived in the Mantuan State to reinforce his Army. This Republick continue their military Preparations. The Marquis Gri-maldi has been to confer with the Duke of Modena and M. de Gages, and upon his Return hither Marquis Durazzo was sent to Nice to have a Conference with the Infant Don Philip. Several Pieces of large Cannon, which were mounted on the Walls of this City, have been taken away and put in the Arsenal, and others of a smaller Size placed in their Stead. This Republick have at last determined to form a Camp near Novi; and two Days ago their Lieutenant General Count de Cecil set out from hence, in Company with M. Villier Camp Marshal, and three Engineers in their Service, to wisit the Fortification of Gavi, from whence they are to go to Novi to mark out the Ground for the Incampment of their Troops. They have entered into a Contract for the supplying their Troops with 30,000 Rations of Bread weekly, and another has been made to supply the Community of Novi with 3000 Mines of Corn monthly, which being twice as much as the ordinary Consumption of the Place, the Surplus, it is supposed, will be applied for the Support of their Army.;

From the Saxon Head Quarters at Landshut, June 6, N.S.

We are not yet able to declare the Loss of the Combined Army, but in all Appearance it will not be found to be much more than that of the Prussian. The Granadier Companies of the Auxiliary Corps joined the Army the Night bafore last, but four of them, with Colonel Schonberg and Lieutenant Colonel Gersdorff who commanded the said four Companies, were misfing. The Rutowski Regiment of Light Drzgoons and the Pulcks of Uhlans likewise came in. Yesterday the Combined Army made a short March, and is disposed in such a Manner, as to cover the two Ways to Trautenau and Schimberg, by which we marched out of Bohemia into Silesia, and also the Magazines behind. This Polition gives an Opportunity to our People that were separated to join the Army. We are raising some Batteries To-day in our Camp here, for employing in its Defence, in CAIE

case of Need, the heavy Artillery, which is all preserved. But as some Time will be requisite for repairing the Damage we have suffered by the Loss, our Stay in this Camp will be short, especially as we are informed that the Prussians marched Yesterday towards Hirschberg.

From the Saxon Head Quarters at Slatin, June 8, N. S.

The Day before Yesterday, at Nine o'Clock in the Morning, we had Advice, that the Prussian Army was in full March to our Camp by Landshut, and that General Nadasti was forced to retreat. As on Account of the considerable Loss of Artillery, Generals, and upper Officers, it was not adviseable to risk and expose ourselves to the dubious Event of another Engagement; and as we did not at first intend to keep the Camp by Landshut, the farther Retreat to Bohemia was refolved upon. The Army disposed accordingly, and the March begun in good Order. This was facilitated by the Precautions already taken of fending the Bazgage before by Break of Day, and the Troops were the join M. de la Farre. less interrupted in their March. General Nadasti, with the Hussars and five Pulcks of Uhlans, formed the Rear Guard of the Combined Army, and, not to divide it, it was thought proper for the Whole to march by Schimberg. Our Rear Guard skirmished for an Hour behind Landshut with the Prussian 'Avant Guard, which had some Pieces of Cannon; sometimes one Side, sometimes the other had the Advantage, as it usually happens in fuch Cases. The Day before Yesterday we came into the Camp by Johnsdorff, and Yesterday into this, and we were not disturbed in our March Yesterday. To give the Troops Time to refresh themselves after the two fatiguing Marches over the Mountains, we halt To-day, but intend to proceed To-morrow to the Neighbourhood of Jaromitz and Konigshoff. Prince Charles intends to have his Head Quarters in the former, and the Duke in the latter, so that the Right Wing will be at Jaromitz, and the Left at Konigshoff. As far as we can learn, the whole Prussian Army is march'd to Landshut, and we have also Reports that it was gone to Hirschberg. Wherefore to prevent the Prussian Army from penetrating into Bohemia by Trautenau, and cutting us from the Communication with Saxony, that Pass is occupied by an Austrian Regiment of Dragoons. Orders are also given for cutting down the Trees, and a sufficient Number of Men will be posted there. Mean Time a Detachment of Uhlans is commanded "to Trautenau, to observe and give Informations of the Motion's of the Prussians.

Dresden, June it, N.S. The Rumour of a second Action between the Prussians and the Allied Armies upon the 6th, arose from nothing but a few Skirmishes between them in the Retreat made by the latter. Not one of the Saxon Generals is kill'd, without it be Major General Schlichting, who was "left behind dangerously wounded. Lieutenant General Polentz is alive, I this Time arrived at Ostend.

and was only thought lost, from being trampled upon by his Horse, as was Lieutenant General Berkholtz and Prince Sonderhausen Major Ge-Major General Durfield, who behaved extremely well, and is thought one of the best Horse Officers in the Saxon Army, received a Cut in his Head, but will foon be able to do Duty. Nor is it affirmed, that any amongst the Austrian Generals, except Thungen, is kill'd. The whole Loss of the Saxons is now said to be less than was at first imagin'd, and that of the Prussians to be very considerable. The Recruiting here goes on very fuccessfully, and it is thought that the Troops at present in Bohemia will be easily completed in three Weeks, by which Time they will likewise receive the Cannon that is wanting.

The Reigning Prince of Desfau has received Orders to make the necessary Regulations for putting the Magdebourg Corps in March immediately.

Hague, June 15, N.S. We hear from Antwerp, that the Battering Train was begun to be embarked upon the Scheld on Tuesday last, and would be all ready to be transported wherever Occasion ! might require in ten or twelve Days.
