Leghorn, August 6, N.S.

HE Republick of Genoa is erecting a strong Battery to the Eastward of the City, near the Lazaretto, which is design'd to flank the others towards the Sea, and render the City more secure from any Attempts of a Bombardment, which the Republick seem to apprehend; the Government had also signified to the Consuls residing there, that they would, for the future, examine all Vessels that might arrive in Port, lest they be Enemies, or filled with Combustibles to blow up the City. On the 22d path, General Schulemberg's Head Quarters was fixed at Reverone, having the Tanaro in Front, his Right extended to Alexandria, and the Left to the Po. The Army had been reinforced with four Regiments of his Sardinian Majesty's Cavalry and 10 Battalions of Infantry, seven Battalions more were in full March also to join the Austrian Army. The whole Riviera to the Westward is in Arms, occasioned by the daily Incursions of the Piedmontese; and the County of Albenga has proited, that rather than suffer it to be ruined, they will submit to his Sardinian Majesty. Letters from St. Remo of the 27th advise, that Count Lautrech was daily expected at Nice with hine Battalions, and it was reported he would ! besiege the Castle of Savorgio. Two French Gallies are arrived at Monaco with fix Field Pieces and a Quantity of Ammunition.

Leghorn, August 9, N.S. Two Days ago his Britannick Majesty's Ship the Lowestoff, brought in here Six Vessels under Neapolitan Colours which were bound to Genoa, loaden with Provisions for the Spanish Army.

Journal of the Saxon Auxiliary Army in Bohemia, from the 13th to the 14th of August, N.S. dated from their Head Quarters at Johannif-berg near Konigingratz.

JPON the 13th we had Advice from Upper Silesia, that the Prussians having received a Check from the Insurgents there, had been obliged to retire to Neisse, in order to post themselves under the Cannon of that Fortress.

We also heard from the County of Glatz, that a Party of Austrians had dispersed a Troop of Prussian Hussars between Wunschelbourg and Politz.

Major General St. Andre sound Means to send some sew of his Men into Habelschwerdt, who destroyed twenty Ovens lately built there for the Use of the Prussians.

The Prussian Corps, which retired some Days ago from Zwol, according to our last Advices, continues its March by Skalitz to Nachod; and it has fince been followed by the Sick and the Baggage by the Road of Schwiritz upon the Confines of Glatz, to which Place, as well as to Falkenstein and the neighbouring Countries, Orders have been fent from the King to hasten the Harvest as much as possible. Lieutenant Colonel Monro sent us Advice, that the Uhlans having the Day before fent a Patrol to the other Side of the Metau to reinforce that already there, they had been attacked by a Troop of so Prussian Horse, who retired afterwards towards an Ambush of their Foot, in order to draw the Uhlans after them. General Nadasti having had Information thereof, detach'd 200 Huffars to support the Uhlans, and thereupon the Piuffian Foot coming out of their Ambush, fired upon them; and then refreated into the Suburbs of Neustadt. Immediately General Nadasti ordered Rudnicki's Pulk of Tartars and his Hussars to invest that Town, and summon'd the Garrison twice by a Trumpet to surrender Prisoners of War. The Commandant return'd for Answer, that so far from complying with the Summons, he was determined to defend the Town. In the Afternoon two Prussian Battalions, and seven Squadrons, with four Pieces of Cannon, were fent from Nachod to the Assistance of Neustadt. But the seven Squadrons having detached themselves a little from the Foot, General Nadasti ordered his Regiment, and the Transitivanians lately arrived, to pass the Metau, and ranged them in one Line in order of Battle. This Difposition obliged the Prussian Foot to return forthwith with their Cannon towards Nahorzan, from whence, having let the Cavalry file off by a Defile, the Infantry afterwards took the same Road; and after having fired feveral Pieces of Cannon, the Whole marched towards Nachod. Count Nadasti had formed a Design to scale the Town of Neustadt, but as the Enterprize would have been too hazardous, on Account of the advantagious Situation of the Castle, which is furrounded with strong Walls, the Generals and Chiefs of his Corps opposed it, so that that Scheme was abandoned. The same Night we had Advice, that five Prussian Battalions, with 42 Pieces of Cannon, had also been sent from Nachod to the Succour of Neustadt.

Colonel Trenk arrived from Jagerndorff with two free Companies. His Regiment, which consists of 3000 Men, is also in March to join the Army here,

By the Reports of Deserters which came in upon the 14th, the Army of the King of Prussia in Camp at Chlom, after the several Detachments made from it, does not consist of above nine Regiments of Horse and 20 Battalions which compose the first Line. There were two Battalions of Grenadiers posted in some Villages upon the Right Wing, and a Third, with a Regiment of Hussars, near the Bridge upon the Elbe. They also reported, that the second Line consisted only of eight Battalions, and that a Regiment of Dragoons was encamped in the Front of the Army.

In order to reinforce the Corps under General Nadasti, 14 Squadrons, under the Command of Lieutenant General Philibert, advanced to Burowina, in order to join 2000 Horse under the Command of Major General Radicati, and 14 other Squadrons were also detached from the Army to take Possession of General Philibert's Post beyond Slatina, on the other Side the Adler.

Prince Charles detached two of the five Battalions posted on the other Side the Adler to Pilletitz. They will be replaced by two Battalions of Damnitz's Regiment, which is encamped here.

We received Advice that the King of Prussia had detached two Regiments of Horse from his Lest Wing to be posted upon the Metau, and that he had sent back to Nachod the five Battalions and 12 Squadrons which had been ordered to march from thence to the Assistance of Neustadt.

Venice, August 20, N.S. Letters dated the 16th from the Austrian Head Quarters at Bassignane advise, that the Garrison of Tortona retired on the 14th into the Citadel, and that they had begun to fire from thence on the 16th in the Morning. The Citadel has a brave and experienced Officer for Governor, is well fortified, has a Garrison of 3500 Men, surnished with every Thing necessary for a good Defence, and it is thought will be able to hold out till October.

Berlin, August 28, N.S. In Consequence of the Manifesto published here, the Prussians have entered Saxony, and the Prince of Deslau has forbid all the Inhabitants of the Country to oppose him upon Pain of the severest military Execution. According to the last Advices received here, their Camp is at Skenditz, a League and an half from Leipsig. It is said they intend to begin the Operations by laying Siege to Witstemberg, and that the Army of his Prussian Majesty in Bohemia will enter Saxony on that Side; and it is even reported, that they are actually filing off towards the Frontiers, and that the Duke of Saxe Weillenfels, with the Body under his Command, will be obliged to retire from Bohemia to cover and defend the Territories of Saxony,

Berlin, Sept. 2, N.S. As the Uhlans, and other irregular Polish Troops, to the Number of 5000 Men, are in the Neighbourhood of Landsberg, about 14 Leagues distant from hence, we are making the pecessary Preparations to refist any sudden Surprize; the Burghers, to the Number of 9000 Men, capable of carrying Arms, are assembled and accoursed, and near 2000 of them mount Guard daily.

Hague, Sept. 3, N.S. Mess. Wasner and Hop, Ministers of the Queen of Hungary and their High Mightinesses, arrived here last Night from Hanover; and the former fets forward for England along with this Mail. Prince Czerbatow is likewise on the Road from thence, and will be here in a Day or two. Lord Harrington arrived here this Evening, and his Majesty is expected to be at Helvoet on Monday or Tuelday next, where the Yachts and Convoy arrived last Monday. Advices from Dresden mention the Prussian Army's having recrossed the Elbe on the 25th past, and posted itself behind the Metau, where it was supposed it could not long remain for Want of Sublistance, all the Country within Reach of his Army being entirely exhausted. . The Letters from France, come in to Day, bring Advice, that a general Embargo was laid on all Ships in the River! Charente, without Distinction of Nation.
