By the KING, A PROCLAMATION,

For putting the Laws in Execution against Jesuits and Popish Priests, and promising a Reward for apprehending them within London, Westminster, the Borough of Southwark, or within Ten Miles of the said Cities of London and Westminster.

HEREAS by an Act of Patlia-ment made in the Twenty-seventh Year of Ouers Electrical Enacted, That it shall not be lawful for any Jesuit or popish Priest, born within this Realm, or any other our Dominions, to come into, or be or remain in any Part thereof, under the Penalty of being guilty of High Trea-Yon, in Case he shall not, within three Days after he shall come into this Realm, submit himself to some Bishop of this Realm, or to some Justice of the Peace, and take the Oaths; and every Person, who shall wittingly and willingly receive or maintain such Jesuit or popish Priest, finall be guilty of Felony without Benefit of Clergy: And by the same Act it is surther E. macted. That if any Subject shall know that any fuch Priest is within the Realm, and not discover him unto some Justice of the Peace, or other higher Officer, within twelve Days next after his faid Knowledge, but willingly conceal his Knowledge therein, then every such Offender shall be fined and imprisoned at the Queen's Pleasure, And whereas it is by an Act of the third Year of King James the First, Enacted, That if any Person shall put in Practise, to abfolve, persuade or withdraw any of the Subjects of his Majesty, his Heirs or Successors, from his natural Obedience to his Majesty, his Heirs and Successors, or to reconcile them to the Pope or See of Rome, or to move them to promise Obedience to any pretended Authority of the See of Rome, or to any other Prince, State or Potentate, then every such Person, their Procurers, Counsellors, Aiders and Maintainers, knowing the same, shall be adjudged Traytors, and fuffer as fuch; or if any Person shall, by

any Means, be willingly withdrawn, or promise Obedience as asoresaid, such Person is thereby made guilty of High Treason. And whereas it is notorious, that great Numbers of such Jesuits and popish Priests taking Advantage of the Lenity of our Government, in not putting the said Laws, and other Laws against Papists into strict Execution, have of late come into or continued in this our Kingdom, exercifing their Functions, and have perverted, or attempted to pervert, many of our Subjects from the Protestant Religion and their Allegiance: And whereas at this Time of open Rebellion in Favour of a popish Pretender to our Crown, all such Jesuits and popish Priests are more particularly dangerous to the Peace and Security of this Realm, and it is necessary that the said Laws should be put into effectual Execution against them, and more especially that they should not be suffered to come into, or remain in or near to our Cities of London or Westminster: And whereas by our Royal Proclamation given at our Court at Kensington the Fifth Day of September last, we did strictly charge and command all Papists and reputed Papists (except as therein is excepted) on or before Thursday the 19th Day of September last, to depart out of the Cities of London and Westminster, and Borough of Southwark, and from all Places within ten Miles Distance from the same: And whereas we have received Information, that notwithstanding the said Laws and Proclamation, many Jesuits and popish Priests are so daring as still to continue and reside within the Cities of London and Westminster, and Borough of Southwark, and within ten Miles of the same; We, for the better discovering and apprehending such Jesuits and popish Priests, do by this our Royal Proclamation, by and with the Advice of our Privy Council, strictly charge and command all our Judges, Justices of the Peace, Magistrates, Officers and other our loyal Subjects. that they do use their utmost Care and Endeavour to discover, apprehend, and bring to Trial, all Jesuits and popish Priests, except such popish Priests not being our natural-born Subjects, as by the Law of this our Realm are permitted to attend Foreign Ministers. And for the greater Encou-

Encouragement to our loyal Subjects in the difcovering, apprehending, and bringing to Justice such Jesuits and popish Priests, we are graciously pleased to promise to him, her or them, who shall discover or apprehend, or cause to be apprehended, any such Jesuit or popish Priest, who shall be found after Monday the Ninth Day of this Instant December, in the Cities of London or Westminster, or the Borough of Southwark, or within Ten Miles of the said Cities, the Sum of One Hundred Pounds for every such Priest, which shall be immediately paid upon Conviction, by our Hgh Treasurer, or Commissioners of our Treasury for the Time being. And in case there shall be any Doubt, who or what Person or Persons shall be entitled to such Reward, and in what Proportion, the same shall be settled by the Certificate of the Judge or Judges who shall try the faid Offence.

GOD Save the KING.

Algier, Oct. 26, N.S. The Dey of this Place and Kingdom, Ibrahim Bashaw, being grown old, and attack'd with a bloody Flux, the Symptoms of which were judged extremely dangerous, he has thought proper to refign his Government, and has caused his Nephew, now Ibrahim Dey, to be invested in that Dignity. This Affair has been happily effected without the least Tumult or Disorder, and feems to be to the Satisfaction of all Sorts of People. What Effect this may have with Regard to the Christian Powers, with whom this Government is now in Peace, Time must tell. But for the British Nation, he has always expres'd the highest Regard both before and since his Accellion.

Hambourg, December 10. By Letters from Dresden of the 5th, Count Grune, the Austrian General, was posted with 10,000 Men, not far distant from Dresden, between which Capital and Pirna the Saxon Army lay. The Polish Court had retired to Toplitz, fix short Miles from Dresden. The Garrison of Dresden confifted of three Regiments of Foot, and the Ramparts were planted with Cannon, &c. so as to be able to make some Resistance upon the first Approach of the Prussians; and the Duke of Weissensels had retaken the Command of the Saxon Army. The Foreign Ministers accredited to the Court of Dresden, had set up before their Houses the Arms of their respective Masters. The Letters which came in this Morning from Berlin mention, a Probability of a speedy Accommodation between the Courts of Dresden and Pruffia; and that his Pruffian Majesty had fent for his Minister Count Podewils to the Army.

Kirby Lonstale, Dec. 2. On Friday last a Party of the Rebel Horse from Carlisle came to Penrith, demanded Quarters for 3000 Men,

whom they reported to be upon the Road, and gave Orders that the Excise Money, Contributions, &c. should be held in Readiness for them. Thereupon the People of the Town fent out Scouts to Penrith Fell to discover the Rebels, but no more appearing, the Fire-Bell was rung, which alarmed and brought together great Numbers from all Parts, and the Horse marched off for the Bridge, and from thence to Lowther Hall, of which they took Possession. The Country People immediately pursued them, surrounded the House, fired into it upon them, killed one, wounded several, and made ten Prisoners with all their Horses. Eight of the Rebels made their Escape over the Water. On our Side only one Man was wounded, who had the Misfortune to be shot through the Thigh.

Edinburgh, Dec. 3. His Majesty's Ship the Milford, Capt. Hanway, sell in with and took off Montrose, on Thursday Asternoon, a French Ship with 210 Soldiers on board, bound from Dunkirk for Montrose, most of which are said to be Ossicers; and as they had Intelligence of more Ships of the same Kind, it is hoped some of them may fall in the Way of Admiral Byng's Squadron.

Stafford, December 4. His Royal Highness the Duke of Cumberland is returned hither with the Army under his Command, which was assembled at Stone by Four in the Morning Yesterday, upon positive Advices of the Rebels marching by Congleton towards North Wales. His Royal Highness's Van Guard was in Motion towards Newcastle, when Advice came, that the Rebels were gone for Leek and Ashboum; and it was thereupon resolved to march the Army as soon as possible to Northampton, in order to intercept them in their March towards the South. The Van Guard will be at Northampton on Friday Nigut.

We have Advice, that at Four this Morning, the Pretender's Son entered Derby with 450 Horse, and 2300 Foot. The rest, with the Artillery and Baggage, were then at Ashbourn, but set forward this Evening for Derby.

Mansfield, Dec. 4. The Rebels were this Morning upon their March from Ashbourn to Derby. By one that saw them we hear, they appear'd to be a good deal satigued, their Yesterday's March having been a very great one.

Whitehall, December 6.

This Day their Graces the Duke and Dutchels of Norfolk, being just arrived in Town from their House in Nottinghamshire, waited upon his Majesty about. James's, and were very graciously received.

Whitehall, December 7.

By Advices from Litchfield, his Royal Highness the Duke of Cumberland arrived there with the Army on Thursday last, and having received Advice that the Rebels had taken Possession of Swarkston Bridge, before the Orders for breaking it down could be put in Execution, it was refolved to encamp the 6th on Meriden Common, between Coleshill and Coventry, and this Day near Northampton, by which Means the Army would be again before the Rebels. The Men, who have been a good deal harassed, bear the Fatigue of marching, and all others, with great Chearfulness, and seem to have no other Wish, than to come to an Engagement with the Rebels.

Whitehall, December 7.

There are Letters from the Camp at Wetherby of the 5th Instant, with Advice, that upon hearing of the March of the Rebels into Derbyshire, Marshal Wade had directed the Cavalry to begin their March that Morning towards Doncaster, and the Foot to sollow the next Day.

The Army halted on the 5th at Wetherby, to receive their Bread from Leeds, and their Shoes, Stockings and Flannel Waistcoats from London, which met them at that Place.

Marshal Wade's whole Army will be at Don-taster To-night.

The following Address of the British Conful, and Merchants, residing at Leghorne in the Dukedom of Tuscany, having been transmitted to his Grace the Duke of Newcastle, one of his Majesty's Principal Secretaries of State, has by him been presented to his Majesty: Which Address his Majesty was pleased to receive very graciously.

To the King's most Excellent Majesty,

The humble Address of the British Consul, and Merchants, residing at Leghorne in the Dukedom of Tuscany.

May it please your Majesty,

Subjects, the Consul and British Merchants at Leghorne, humbly beg Leave to congratulate your Majesty upon your safe and happy Return to your British Dominions, as well as upon the Success of your Majesty's Forces in the Taking of Cape Breton, a Conquest so beneficial to your Trading Subjects in general.

Permit us, Sir, to testify our Gratitude to your Majesty, for your paternal Care of us in this our Settlement; where, whilst we were surrounded with our Enemies, your Majesty (who has ever the Sasety and Welfare of your Subjects at Heart) at once was graciously pleased to turn your Eye upon us, and remove our Fears, in signifying to us by the Admirals, who

had the Honour to command your Majelty's Fleet in the Mediterranean, and likewise by your Resident at Florence, that your Majesty had given the former the most pressing Orders to protect us, in our Persons and Essects, at all Events.

We beg Leave to express to your Majesty our utter Abhorrence and Detestation of the wicked Designs carrying on in Favour of a popish Pretender, and to give your Majesty the strongest Assurances of our Duty and Loyalty, even to the Sacrificing of our Lives and Fortunes in the Desence of your Majesty's sacred Person and Royal House, the Protestant Religion, and the precious Liberties we enjoy under your Majesty's gracious and mild Government.
