Parties taken above 800 Prisoners on the other Side of the Po; and that the Spaniards were

preparing to retire in Haste from Milan.

Hague, March 29. The Head of the first Column of Austrians from Bohemia, consisting of the Regiments of Bentheim and Ghylani, arrive as this Day, the former at Diest; the latter at Firlemont. The three Squadrons of Horse Guards march out of this Place Tomorrow Morning for Breda, to put themselves under the Orders of the Prince of Waldeck, whither all the Troops the States can gather together are likewise repairing. General Molke is come over hither to meet Marshal Bathiani, who is expected here from Day to Day. The French Letters bring nothing material To-day, beyond the Confirmation of the Return of most of the Transports with the Irish Troops on board, into the Harbours of Ostend and Dunkirk.

- Pennyn in Cornwall, March 17. Last Thursday the Saltash and Warren Privateers Tell in with a Fleet of small Vessels, which were lying at Anchor near Port Louis, laden mostly with Stores, particularly Timber for Ship Building, for the Service of the French King. There were about 30 of them together; with an Arm'd Vessel, which served as Convoy to them. The Privateers above-mentioned attacked them, the one on one Side of the Fleet, and the other on the other Side, so fuccessfully, that they brought off five of them, viz. four of the Store-ships, and the Arm'd Vessel, which mounted ten Guns, and which, with two of the said Ships, was this Evening brought into this Harbour by the two Privateers that took them, and two others are behind, which they parted from last Night, but are in hourly Expectation of. Sixteen of the others were driven ashore by them, which they despairing of getting off, endeavoured to deftroy, and did actually burn two, as they would have done the rest; but a Man of War of considerable Force coming out of the Port, obliged them to make off as fast as they could for their own Security. There were so few Men on board the Prizes, by reason of their lying so near the Shore, and making their Escape upon the Approach of the Saltash and Warren, that they have brought in only two Men Prisoners.
