An Account is received from the Earl of Craufurd, that two or three small Parties, posted at different Places in the Neighbourhood of A(hol, have been surprized by the Rebels, and

the Men either killed or taken Prisoners.

Perth, March 19. The Prince of Hesse came to Dunkeld on Friday last, and returned hither on Saturday. There are Accounts, that a Party of Argyllshire Men, under the Command of Glenure, quartered at the Foot of Kanach, were attacked by a Party of the Rebels on Monday the 17th Instant, at Two o'Clock in the Morning, and either killed or taken Prisoners. Orders have been received at Pitlochty, fix Miles below Blair, figured by some of the Rebels, to raise the Men in Athol; and the Rebels, have placed Guards all the Way between Blair and that Place, which stops all Communication from Dunkeld to Blair. The Rebels have surprized two Parties of the Argyllshire: Men, which were posted at Blairsettie and Kennochan, one three Miles, the other fix Miles above Blair. The Party at Cushiville, three Miles from Castle Menzies, is said to have retired to the Garrison there. It is added, that Lord George Murray, with a Body of the Re-, bels, has actually attacked the Castle of Blair; and that there was another Body of them within Three Miles of Castle Menzies.
