N Express, which arrived on Sunday last from his Royal Highness the Duke of Cumberland, brought the following Advices.

Aberdeen, April 6. His Royal Highness the Duke of Cumberland will begin his March Tomorrow towards Inverness, where he proposes to be on the 17th Instant. All the Intelligence we have had for these two Days past about the Rebels, has been only a Confirmation of their Confusion and Mutinies; and we hear that they desert from all Parts. Captain Mac Kay, Lord Reay's Son, and Sir Henry Monro, Son to the late Sir Robert, both Captains in Lord Loudoun's Regiment, are just come hither with Letters from Captain O Brien of the Sheerness Man of War now off this Place, giving an Account, That after chasing the Hazard Sloop (salled by the French the Prince Charles Snow) above 56 Leagues, he drove her ashore, and obliged the French and Spaniards who were in her, to quit her, and to land, which they did, with five Chests of Money, to the Value of 32000 l, and upwards, in order to join the Rebels; but the Lord Reay, in whose Country they were landed, and at whose House Captain Mac Kay, Sir Henry Monro, Lord Charles Gordon, and Captain Mac Cleod, with some other Officers of Lord Loudoun's Regiment were, with about 80 Men of the same Regiment, who had been driven thither by the Rebels, marched out and attacked them, and after killing three or four, and dangerously wounding eight, took the remaining 156 Officers, Soldiers and Sailors, Prisoners, who were immediately embarked on board the Sheerness; and the Prize, with the Highland Officers and Men, who made this Capture, are now here. The Captain of the Sheerness also picked up, in the Orkneys, a Ship of Boston in New England, commanded by one Sinclair, who had ome Arms and Ammunition on board, and had put himself into the Power and Service of the Rretender. His Mate and Men had before quitted, him; and upon the Sheerness's saming into the Harbour of Stromness, he, li

and the Highlanders who were with him, got off in the Boat, but Captain O Brien has brought off the Ship, with what Arms and Ammunition were on board. The Prisoners on board the Sheerness are ordered to be sent to Berwick. There is one Colonel Brown on board, who made his Escape from Carlisle, after the Surrender of the Town was agreed upon.

The Money, which was landed out of the Hazard Sloop, was taken by Lord Reay's Men.

The Day after Captain O Brien took Possession of the said Sloop, he sound on board her, 14 Chests of Pistols and Sabres, with 13 Barrels of Powder, design'd for the Use of the Rebels.

Aberdeen, April 7. The March of the Army for Inverness is deferred 'till To-morrow. We hear from Dunkeld, that the Rebels having raised the Siege of Blair, and retired with the greatest Precipitation upon the Approach of the Troops sent to relieve that Place, the Prince of Hesse was to return to Perth as this Day, and to encamp there with all the Six Hessian Battalions, except 500 Men that are to remain at Taybridge; that St. George's Dragoons were to be cantoned in and about Huntingtoun, and the two other Regiments were to repair to Crief.

Edinburgh, April 9. The French Privateer, said to have landed some Officers and Men in Lord Reay's Country, comes out to be the Hazard Sloop. Lord Reay, who arrived at Leith Yesterday, gives the sollowing Account of her

being taken.

On the 25th of March the Hazard Sloop was observed by Lord Reay and his People sailing up the Tongue Bay, and was soon follow'd by Capt. O Brien in the Sheerness, who immediately attack'd her. In the Engagement the Hazard Sloop had several Men killed, besides a good many wounded, and not being able to maintain the Fight, she run ashore on the Shallows, where the Sheerness could not follow, and there landed her Men and Money. Lord Reay's Sons, with some other Officers, gather'd what Men they could together, attack'd those that landed from the Hazard Sloop, and, after killing five of them, took the rest Prisoners, and feized the Money, faid to be 12,500 Guineas; but one Chest of it was missing, and another broke. Lord Reay and his Friends being apprehensive of a Visit from the Rebels, embarked with their Treasure and Prisoners, and arrived on Sunday Night at Aberdeen with the Hazard Sloop; and in paffing the Orkneys, Capt. O Brien brought along with him the Boston Ship, that was treacherously seized by Capt. Sinclair for the Rebels. It is said that Sir James Stuart of Burray has raised 300 Men in those Parts for the Rebels, who are plundering Earl Morton's Estate. Lord M'Cleod was arrived in Caithmess with 3 or 400 more, and endeavouring to raise greater Numbers: His Success is variously - reported.

There were scarce any French, except Sailors, on board of the Hazard; the Officers and Soldiers are mostly Irish, and some Scotch, commanded by one Brown.

The three large Ships seen off Holy Island, appear now to be three Dutch Men of War sent to join Commodore Smith.

de Castellar, who was supposed to have marched from Parma towards Placentia, having had No. tice that General Nadasti was posted at Borgo St. Donino, between those two Cities, had shut himself up again at Parma; whereupon Genegal Brown hastened with his whole Army from Sorbolo by Colorno to Borgo St. Donino, with a Design to oppose a Succour of 12000 Men, which he was informed was coming from Placentia to M. de Castellar; so that we are in Expectation of hearing every Moment of the Success of this Enterprize, which is become the more important, as by Advices from Prince Lichtenstein of the 5th Instant, this Court has News, that the Spaniards had evacuated Pavia the Day before, and were marched to Placentia. The Prince adds, that he does not doubt of Valentia's having been evacuated at the same Time, which last Place the King of Sardinia had undertaken the Siege of, while he, Prince Lichtenstein, was, by his Sardinian Majesty's Consent, in Motion to join General Bernclau upon the Tessin on the Side of Pavia. As the Spanlards are gone from Pavia to Placentia, which may put General Brown into some Danger at Borgo St. Donino, between Placentia and Parma, General Bernelau has marched back with the greatest Diligence to join General' Brown, which it is hoped may be done in Time. at or about Cremena, the Distance being about equal from Milan to Cremona, and from Pavia to Borgo St. Donino, and the latter not being above ten Italian Miles distant from Cremonal In the mean while the French, who are at No-k vi and Gavi, and who are said not to have been suffered by the Spanish Garrison to enter into Tortona, are looked upon, for the present, as: out of Play, till the Arrival of the 25000 Men, which it is faid the Court of Verfailles has order dered into Italy through the River of Genoal The Spaniards having now all passed the Po, is is hoped General Brown will be able to hinder their Retreat into the Ecclesiastical State, which it is supposed must be their principal Design in evacuating Pavia, in order to assemble at Pl. centia.

Capenhagen, April 16. The Equipment of the three Danish Ships intended for the Mediter ranean, goes on very briskly; 'tis thought they' will be ready to sail about the Middle of next Month. Three or four hundred Waggons with inlisted Sailors, are just now coming into the Town.

Hambourg, April 19. The Russian Resident has received from his Court a Rescript, consirming the Death of the late Regent Princess of Mecklenburg, and informing him at the same Time of the Funeral Ceremonies which the present Empress had thought sit to have solemnized for that unhappy Princess, in the Convent of Alexander Newsky, where her late Mother the Dutchess lies likewise intert'd.

morrow. The French also begin to be in Motion, but are not yet, it is supposed, assembled in any considerable Body. It is said, that all the Infantry has Orders to pick out ten of their best Men per Company, who are to hold them-Telves in Readiness to march upon some secret Detachment at an Hour's Warning. The Fortifications of Ath are demolishing. The Paris Letters mention the Junction of the Austrian Corps in the Parmelan being effectuated, and M. Gages having fent off, some Days before he evacuated Pavia and marched to the Relief of Parma, most of his Artillery and heavy Baggage over the Bocchetta towards Genoa; to that we are in hourly Expectation of the News -of some decisive Action's having past between Placentia and Parma.
