Algier, February 10, O. S.

HIS Government is now making extraordinary Preparations for sending a Body of 4000 Turks, which, it is faid, will be joined with about 2000 Horse, and some Moorith Troops, to dethrone the Bey of Tunis, and place the Son of the late Bey, now here, in his Stead.

Bedford, off Cape Corse, April 7. Upon the 22d of March Commodore Townthend arrived at Mahon, and after victualling and watering his Ships, and getting every thing ready for Sea, he sailed upon the 29th of that Month for Cagliari with some Men of War and Bomb Vessels. In his Passage he fell in with four large Ships and two Polaccoes, which he chased and discovered to be French Men of War, and by the best Observations he could make, found them to be a Squadron under the Command of M. de Lage from Toulon. As the Commodore had the Bomb Vessels and their Tenders under his Convoy, he made the best of his Way to Cagliari, but going round the South End of Sardinia, he fell in with the same Number of Ships again, which he chased, till he was plainly convinced they were the same, and that they had been lurking about him in order to pick up his Convoy, which however he prevented, by carrying them all safe into Cagliari, where he left them. Upon the 3d Instant the Commodore was joined by the Antilope, which he immediately took under his Command, and the next Day sailed for Corfica, where he proposed to join the Ships station'd there, and with that Reinforcement intended to go in quest of M. de Lage. By the best Accounts, Bastia was again in the Hands of the Genoese, or at least some of the Corsicans that espouse their Cause.

Naples, April 19, N. S. On the 15th, early in the Morning, here happened an Hurricane, which lasted till Noon, and ended with great Rains. The extraordinary Swell of the Sea gave great Alarm to the Inhabitants of this City, and has damaged many of the Vessels in Port.

Verona, April 22, N.S. By our last Accounts the main Body of the Austrians was encamped upon the Taro about two Miles distant from Parma. There is a Detachment of about 7000 Men at Codogno, to observe the Enemy's Bridge, and to cover her Imperial Majesty's Dominions on this Side of the Po. The Enemy have their Head Quarters at Borgo San Donino, where the Infant Don Philip likewise was, and their Army was encamped on the Taro, opposite to the Austrians. The Trenches before Valentia were to be opened upon the 18th at Night: Here is a Report that M. de Gages is retiring towards Placentia.

Turin, April 23. A confiderable Body of our Infantry, under the Command of Baron Leutrum, sat down before Valentia on the 17th Instant, and the Trenches were opened in the Night between the 19th and 20th. There were not above 20 Men kill'd and wounded, and four Officers slightly hurt, in that Operation,

and it is thought here that we shall be Masters of the Place on Wednesday or Thursday next. Leghorn, April 25, N. S. By Letters from

Rome of the 16th Instant there is an Account, that two Squadrons of Neapolitan Cavalry, after having halted 15 Days at Viterbo, had received Orders to return, and that they accordingly arrived upon the 15th at Tivoli. Letters from Lucca of the 23d Instant mention, that General Nadasti had come up with the Marquess de Castellar's Corps, and had cut a great many to Pieces. The same Letters add, that M. de Gages was retreating from the Banks of the Taro, under the Cannon of Placentia. Letters of the 17th from Porto Spetia bring Advice, that a small Detachment of Hussars and Warasdins had made an Incursion into the Luneggiane, and facked the Fief of Gropoli, which belongs to the present Doge of Genoa, Marques Francis Brignoli, and besides carrying away the Factor and all the Furniture belonging to the Marquess's Palace, had taken 400 Fufils. Letters from St. Remo mention, that about 200 French Recruits, and 60 Horses to remount the Cavalry, had passed through that Place in their Way to join the French Troops in the Polcevera; and that M. Cossel and M. Maisli, French Majors General, had also passed by, and reported, that 15 Battalions of French Troops were shortly to follows and that 20 others would be employed in an Attack upon Exilles. The fame Letters say, that the Piedmontese Troops encreased daily at Broglio, Sospello, and Savorgio, with Design, as was thought, to attack Villa Franca, and by that Means cut off the Communication with the Spanish Army in Lombardy, or to make an Incursion into the State of Genoa. Upon the 20th Instant arrived here his Britannick Majesty's Ship the Antilope, which was sent hither by Commodore Townshend, to order the Ships that were cruizing upon this Coast to join him immediately, to go in quest of M. de Lage, who sailed some Timesince from Toulon with four French Ships of War, and had been feen by the Commodore in his Majesty's Ship the Bedford, as he was convoying the Bomb-ketches from Mahone to Cagliari; and accordingly upon the zist, the Commodore was joined by three other of his Majesty's Ships off this Port, and they all stood away together to the Eastward. Two Days ago arrived three French Polaccoes, that were taken by his Majesty's Ships Diamond and Leostoff, which were left cruizing off Cerigo. Their Cargoes, which confist of Cottons, and sundry other Goods, are valued at upwards of 60,000 Dollars. The Master of a Swedish Ship who is arrived here; reports, that 13 Days ago he was visited, near the Channel of Malta, by a French Ship of War of 40 Guns, and in about two Hours afterwards by two English Ships, and in a short Time after he heard several Guns fired, which he believes must be between the said English Shipsand the French Man of War, but cannot give any Particulars of the Engagement.

mander of his Britannick Majesty's Ship the Leopard, having been dispatched by Vice Admiral Medley, to the Coast of Genoa, has taken a French Polaccoe, off St. Remo, and conducted her to Leghorn; and had on the 3d Instant, O. S. sunk and destroyed in Dian Road, on the Coast of Genoa, eight Vessels, three under Genoese Colours, and five under the Pope's, most of which were laden with Corn. This had occasion'd the utmost Alarm on that Coast, where the Want of Provisions is represented to be very great.

Liege, May 13. Upon the 11th Instant in the Morning, our Bishop, accompanied by Count Horion, and the Mayor of this City, set out Post, in order to pay his Respects to the French King

at Louvain.

Brussels, May 15, N.S. Upon the 10th Instant, thirty six Carriages arrived here, sull of wounded Men belonging to the Regiment of Piedmont, which was lately attacked upon the Causey by the Austrian Hussels. Upon the 11th our Army, and that under Marshal Bathiani, were in Sight of each other, and it was expected we should have attacked the Allies, but nothing was done. The French took Possession of Malines on Friday last.

Hague, May 13. According to the Accounts received by this Morning's Letters from Brabant, of the late Motions of the French, the Siege of Antwerp seems likely to be the first Object of their Operations. Upon the 11th Instant the French Army presented itself in order of Battle, which obliged ours to draw up, and stand under Arms near 24 Hours; but the French not attempting to force the Passage of the River, no Blows were exchanged. The French have fince began to batter Fort Marguerite, and sent a Detachment, the Success of which is not yet known, to attack General Swartsenberg's Post at Boom, over-against Willebroek. In the mean time, Marshal Bathiani has thought it advisable to draw near the Scheld, and Antwerp; and was Yesterday encamped behind the Neete and the Rupel, from Duffel towards the Scheld, by which Motion the French are already Masters of Mechlin and the Dyle. We have no News from Italy fince last Post. It is said here, that the French Armament was not sailed out of Brest Road on the 6th Instant, N.-S.

Hague May 17. The Report of the actual Attack of Fort Marguerite proves to have been premature, and to have taken its Rise from some random cannonading of the Enemy's; and the Attempt upon Boom has likewise ended in some idle Firing across the Rupel. The French have passed the Dyle, and were Yesterday Morning encamped with their Rear at Mechlin, and their Vanguard at Putten, within Half an Hour of our Lest Wing. And Marshal Bathiani, upon being informed by General Baronai, that a considerable Body of the Enemy was marching round by Arschot, as if their Design was to turn and flank his Army, has sent off the Baggage and heaviest Cannon to Braxschoten Heath, and taken the Resolution of tetreating, as last Night, with the whole Army to Antwerp, in order to cover the Frontier of the Republick, and to pre-Serve A Communication with his Subfistance. The Strength of the French King's Army is vazioully reported; the most moderate Accounts make it amount to Ninety Thousand. Letters from Turin of the 3d Instant mention the Reduction of Valentia on the 2d. Marshal

Maillebois having receiv'd a Reinforcement from France, was marching with 28 Battalions, and 1000 Herse, to the Relief of that Fortress, and having surmounted the Opposition he met with at Acqui and Alexandria, was beginning to lay Bridges over the Tanaro. Upon the Approach of this considerable Succour, General Leutrum determined to attack Valentia Sword in Hand, which he accordingly did in the Night between the ist and 2d, and had the good Luck to make himself Master successively of several Redoubts, and the two cover'd Ways, and having disposed every thing for a general Storm against Break of Day, the Governor offer'd to capitulate upon honourable Terms, which, it is supposed he obtain'd, although the Turin Letters, which make positive Mention of the Capitulation's having been signed the 2d about Noon, are filent as to the Conditions of it. Prince Lichtenstein, after having detached and posted a small Corps at Pontremoli, to cut off M. Castellar's Escape into the Territory of Genoa, is supposed to have passed the Taro on the 5th Instant, as M. de Gages is to have retreated towards Placentia. It is said that the French King has demanded a Passage, and 100,000 Rations, for a Corps of Troops to be detached a through the Country of Liege, and that he has fince had an Interview with the Bishop of Liege at Louvain.
